He has submitted his objection that his name was not included in the provisional seniority list communicated vide reference cited but in the tentative list, he was placed at SI.No.38 and requested for inclusion of his name in the seniority list.

Remarks:

His objection is examined and found correct. It is verified from the tentative seniority list communicated during the bifurcation of PRED into PR & RWS&S Department and found that his name was placed at SI.No. 33 (Seniority SI.No. 38) in the tentative Seniority List.

Sri K. Murali Krishna, Asst. Engineer was appointed during the year 1979 and joined duty on the F.N.of 05.11.1979 (Date of Birth 19.08.1961). With reference to his date of joining his name is placed below Sri B. Mohan Rao, AE (Date of birth 11.04.1957), whose date of joining is 05.11.1979 and above Sri Y. Murali Krishna, AE, whose date of joining is 06.11.1979 (Date of birth 01.06.1957).

Further it is informed that the name of Sri Ch. Sudhakara Rao, Asst. Engineer, PR of Zone-III, whose name was placed in the tentative seniority list, was not find place in the provisional seniority list communicated vide reference cited.

Sri Ch. Sudhakara Rao, Asst. Engineer was joined on 24.10.1979 (Date of birth 01.08.1953). With reference to his date of joining his name is placed below Sri M Ramachandraiah, Asst. Engineer (date of birth 01.01.1958), whose date of joining is 03.10.1979 and above Sri G.Kondaiah (Date of birth 01.07.1958), whose date of joining is 31.10.1979.

Further it is informed that the name of Sri B. Venkateswaralu, whose date of birth is 04.06.1958 was wrongly spelled as Sri A. Venkateswarlu, AE (Sl.No.3) in the provisional seniority list, duly mentioning the date of birth as 04.06.1958. After verification from the connected records, it is found that the name of Sri B. Venkateswarlu is spelled wrongly.

Accordingly, the name of Sri A. Venkateswarlu, Asst. Engineer, PR of Zone-III was corrected as Sri B.Venkateswarlu, Asst. Engineer.

Further the following (3) individuals were repatriated from Zone-III to their respective local cadre zones as per G.O. 610 and their names were deleted from the confirmed seniority list.
