In view of the orders of the Hon'ble Courts vide reference 1<sup>st</sup> to 3<sup>rd</sup> cited, and instructions of the Government vide reference 4<sup>th</sup> cited, a provisional seniority list of Assistant Engineers of Zone-I covering the (14) belated Assistant Engineers of G.O.413 batch and Draughtsman Promotees 1984 & 1990-91, PSC 92, transferred / absorbed from other Dept. and A.P. Scooters was prepared with reference to the dates of commencement of probation as per rule 16(h) of A.P. State and Subordinate Service Rules and communicated to the individuals duly inviting objections vide reference 12<sup>th</sup> cited.

In view of the orders of the Hon'ble APAT in the reference 7<sup>th</sup> cited and as per the instructions of Government vide references 8<sup>th</sup> to 10<sup>th</sup> cited, a provisional inter-se-seniority list of Assistant Engineers of Zone-I between promotees who were promoted /appointed from the feeder category of Draughtsmen / Work-Inspectors and direct recruits who were selected through A.P. Public Service Commission as per Special Rules issued vide G.O.Ms.No.296, PR&RD and Relief (Estt.II) Dept., dated 20.5.1994 for A.P. Panchayati Raj Engineering Subordinate Service was prepared duly following the quota earmarked for promotions and direct recruitment as per statutory rules in G.O. Ms.No.296, dt.20.5.1994 and as per the Hon'ble APAT orders dated 17.12.2009 in O.A.No.7702/2006 with MA No.446/2008 filed by Sri R.Ramachander, Assistant Engineer and (25) others, and communicated duly inviting objections vide reference 11<sup>th</sup> cited.

In response to the above, certain individuals have filed objections, which are discussed and disposed of as follows:

- 1. Sri Y.Bala Raju, Dy.E.E., PR, Etcherla, Srikakulam dist.
- 2. Sri R.Krishna Kumar, Dy.E.E., GVMC (OD) Visakhapatnam
- 3. Sri V.Raghunadha Rao, Dy.E.E., PIU Sub-dvn., Srikakulam
- 4. Sri B.Mallikarjuna Rao, Dy.E.E., RWS&S, Palakonda, Srikakulam dist

#### Gist of objection:

The main objection is that while declaring their probation the procedure as per rule 18 (a) (b) (i) is not followed and therefore they requested to examine their cases in the light of the provisions under rule 18 b(ii) and duly declaring their probation with retrospective effect and restore their seniority.

#### Remarks:

All the above were appointed as Assistant Engineers and their services were regularised in terms of G.O. 413 duly restricting to the date of joining of last regular candidate in the Zone-I i.e. Sri P.Vijaya Raju, A.E. (Limited Recruitment 1982) i.e. 10.8.1982. All the above individuals have not passed Account test within their prescribed period of probation.

Regarding Rule 18 b(ii) of APSSS Rules 1996 as contended by the individuals, it is informed that they have ignored the provision under the said rule stating that "nothing in this sub-rule shall apply to a probationer who has failed to acquire the special qualifications or to pass the special tests, if any prescribed in the special rules or to acquire such other qualifications, as may be declared by the State Government or by the appointing authority with the approval of the State Government, to be equivalent to the said special qualifications or special tests, within the said period of probation". Thus the above individuals have no right to get their probation commenced from their date of joining as they have not passed Account Test for PWD Officers and Subordinates within their probation period. Hence, their objections are rejected

# II Sri N.Ravi Kumar, Dy.E.E., RVM(SSA) (OD) of Zone-I

# Gist of objection:

His objection is that in the seniority list the A.Es. of G.O.-413-batch who passed Account test belatedly were only shown duly eliminating certain G.O.Ms.No.647-batch and requested to follow the method laid down in G.O.Ms.No.244, dt.6.6.1963 and Hon'ble High Court of A.P. judgement dt.18.12.2008.

#### Remarks:

The contention of the individual is not correct since the rule 16(h) provides that nothing in this sub-rule shall apply in the case of persons appointed to the class, category or grade in a service prior to the 9th March, 1981 and whose seniority in the said class, category or grade was fixed under sub-rule (b) of Rule 33, prior to the said date. Thus the A.Es. who were appointed on temporary and later their services were regularized in terms of G.O. 647, dt.14.9.1979 prior to 9.3.1981 did not come under purview of rule 16(h). Hence, his objection is rejected

#### III Sri P.Dharma Rao, AE, PR, Srikakulam

#### Gist of objection:

He has submitted his objection that his probation was declared w.e.f. 26.2.1987 whereas the probation of Sri V.Raghunadha Rao, was declared w.e.f. 24.12.1987 and requested to rectify his seniority.

# Remarks:

In this office Procs.No.SO.I(2)/5846/2013, dt.20.6.2013 the commencement of probation was revised duly taking into account of date of passing of account test (result declared by APPSC). Accordingly the date of commencement of probation in respect of Sri V.Raghunadha Rao, who was appointed as A.E. under GO-413 and passed Account test for PWD Officers and Subordiantes on 4.12.1987 was shown as 5.12.1985 whereas Sri P.Dharma Rao, who was promoted as A.E. from the category of Draughtsman during 1984 has passed Account test on 5.11.1986 was shown as 6.11.1985. Based on the revised date of commencement of probation their names are arranged in the seniority. So their placements shall be arranged w.r.t. their revised dates of commencement of probation. Hence, his objection is rejected.

#### IV

# 1. Sri B.Krishna Murthy, A.E., PIU Sub-dvn., Ponduru

# Gist of objection:

He has submitted his objection on his placement at Sl.No.29 of provisional seniority list duly stating that the A.Es. at Sl.No. 18,19,20,21, 22 and 23 are promoted after his promotion and they are also joined as A.Es. after date of his joining and requested to place them below him as he was deemed to have been temporarily promoted A.E. from the date of joining w.e.f. 17.4.1990.

# 2. Sri N. Venkata Rao, Dy. E.E.

Gist of objection:

He has submitted his objection that his date of commencement of probation was shown as 1.2.1991 instead of 8.5.1990 erroneously. He has also requested to mention his B.Tech. against his name.

#### Remarks:

During 1990 certain Draughtsmen were temporarily appointed as Assistant Engineer vide Procs. No.D1/25347/89, dt.11.4.1990 of Chief Engineer, RWS & Admn., Hyderabad. Later vide Procs.No.No.D1/51299/90, dt. 28.12.1990 of Chief Engineer, RWS&Admn., Hyderabad it was clarified that their appointments were made under rule 10 (a) (i) as A.Es. in relative zones out of turn in the seniority list of Draughtsman by following rule of reservation, now their turn for temporary promotion as Assistant Engineer in the relative zones have come up and therefore, they are deemed to have been temporarily promoted as Assistant Engineers from the date of joinig of their senior in the order of seniority of Draughtsmen of relative zones. Their objections are found to be unstainable and hence, the same are rejected.

The B.Tech. qualification acquired by Sri N. Venkata Rao, Dy. E. E. is shown against his name

- 2. Sri S.Appala Naidu, A.E., Chodavaram, Visakhapatnam dist.

# Gist of objection:

They have has submitted their objection on their placement in the provisional seniority list and stated that S/Sri K.Sudhakar Rao, S.V.Raman Rao, S. Eswara Rao and S.V.S. Prakash and P.Ram Mohan Rao & K.V.Satyanarayana are juniors to them in the category of Draughtsman Gr.III and as well as A.E. cadre when compared to their date of joining as AE i.e. 21.4.1990 and 20.4.1990 respectively duly enclosing un authenticated copy of list of Draughtsmen in support of their claim and rquested to re-examine the seniority and place them at appropriate place in the seniority list below their names.

#### Remarks:

They were initially temporarily appointed as Assistant Engineers under rule 10 (a) (i) as A.Es. out of their turn in the seniority list of Draughtsman by following rule of reservation. Later it was clarified and ordered that they are deemed to have been temporarily promoted as Assistant Engineers from the date of joinig of their senior in the order of seniority of Draughtsmen of relative zone. Hence, their objections are rejected.

# V Sri S.V.B.Prasad, AE, MP, Paderu, Visakhapatnam dist.

#### Gist of objection:

He has submitted his objection and requested to include his community category as SC in the Annexure duly enclosing an attested copy of Caste certificate.

His request is considered and his community is shown against his name.

# VI Sri K.V.Rama Rao, Assistant Engineer, P.R., Vizianagaram

# Gist of objection:

He has stated that he acquired B.Tech. (Civil) in 2009 and requested to correct his qualification as B.Tech.(Civil) instead of LCE.

The B.Tech. qualification acquired by him is shown against his name.

VII Sri Ch.Jayaram, AE, PIU Sub-dvn., Anakapalli, Visakhapatnam dist.

Gist of objection:

He has submitted his objection that he passed Account test on 20.1.2000 as per the results declared by APPSC and requisted to revise his date of commencement of probation as per date of result declared by APPSC instead of gazette date.

# Remarks:

He appeared Account test during Nov.1999 and the results were published in A.P. Gazette on 31.8.2001. Based on this date, his commencement of probation was determined and placed in the provisional seniority. Later vide Procs.No. SO.I(2)/5846/2013, dt.20.6.2013 of Engineer-in-Chief (PR) Hyderabad his date of commencement of probation is revised w.r.t. date of declaration of result by APPSC as 21.1.1998. Accordingly his placement is given in the confirmed seniority list.

VIII Smt. M.Mohana Kumari, A.E., PRI Dvn., Visakhapatnam

Gist of objection:

She has submitted that her date of commencement of probation was shown as 18.3.1995 instead of 4.10.1994. She has also stated that though the A.Es. at Sl.No. 2 and 9 have joined after her on 6.10.94 and 4.11.1994 respectively, they are shown as seniors to her in the seniority list. She has requested to place her name above them w.r.t. to her date of commencement of probatin i.e. 4.10.1994.

#### Remarks:

She has joined as A.E. on 4.10.1994 on promotion as A.E. from the category of D-Man. But she has not completed (3) years of service in the feeder category of Draughtsman and completed (3) years of service by 17.3.1995. As per service rules she is eligible for promotion to the post of A.E. w.e.f. 18.3.1995 only. Accordingly her commencement of probation was shown as 18.3.1995 in the provisional seniority list. Hence, her objection is rejected.

#### IX

(a) Sri K.Sudhakara Rao, A.E., PIU Sub-dvn., Yellamanchili

Gist of objection:

He has submitted objection stating that he is physically disabled person and requested to fix roster under rule 22 of AP State and Subordinate Service Rules and shall follow in case of promotions i.e. 6<sup>th</sup>, 31<sup>st</sup> and 56<sup>th</sup> and requested to fix his seniority duly considering the roster points.

#### Remarks:

The contention of Sri K.Sudhakara Rao, A.Es. is not correct since there is no provision to follow roster for P.H. candidates in promotions effected during 1990-91. The orders for providing trifurcatin of the 3% reservation for each category of disabled have been issued in G.O.Ms.No.42, dated 19.10.2011 duly directing the heads of departments to issue necessary amendments to A.P. State and Subordinate Service Rules 1996 and special rules of the respective Dept. wherever necessary for strict implementation of rule of reservation in promotions to the employees with disabilities in the State Govt. As far as concerned to PRED no amendment in this regard are made to APPRES / APPRESS Rules so far. His objection is found to be unsustainable, hence the same is rejeted.

(b) Sri S. Somasekhar, A.E., PRI Sub-dvn., Yellamanchili

Gist of objection:

He has submitted objection stating that he is physically disabled person and requested to fix roster under rule 22 of AP State and Subordinate Service Rules and shall follow in case of promotions i.e. 6<sup>th</sup>, 31<sup>st</sup> and 56<sup>th</sup> and requested to fix his seniority duly considering the roster points.

#### Remarks:

He was appointed during 1998-99 through APPSC against OC/PH roster point in Zone-I. As per the rank list communicated by the APPSC, his name was shown in the seniority. His placement in the seniority is in order as per roster.

All the above A.Es. belong to RWS&S Dept. have submitted their objection as follows:

# Gist of objection:

They have stated that the (25) temporary promoted Assistant Engineers who have got temporarily appointed by promotion from the cadre of Draughtsman after 14.3.1990 are not entitled to get promotion as Assistant Engineer, before the PSC 1998 A.Es. since their temporary appointments could not be regularized and their probation was also not declared because of non availability of vacancies under promotee quota. Hence, the seniority list of A.Es. prepared and communicated, placing the temporary A.Es. above the PSC 1998 A.Es. is irregular, unconstitutional as per judgement issued by the in the W.P. in the case of PSC 1984 AEES. Vs. temporary AEEs. Regularized under GO 413. They have requested to place the temporary A.Es. at Sl.N0. 1 to 25 and Draughtsman promotees 1991 below the last regular A.E. of PSC 1998 since their appointments as A.Es. by transfer were not made till to day after promulgation of Act 94.

Sl. No. 1 and 3 have requested to show their M.Tech. and B.Tech. degrees, respectively in the seniority list.

# Remarks:

As per service rules issued in G.O. 296, dt. 20.5.1994, (50%) of the vacancies of A.Es. shall be filled by promotion / appointment by transfer from the feeder categories and (50%) are to be filled by Direct recruitment. The posts meant for promotions were filled with feeder categories during 1994. They are shown in the seniority list and they have occupied the quota meant for promotees only as per rules. They have joined much earlier than the direct recruits and rendered considerable service prior to the appointment of Direct Recruits. Hence, the contention of the direct recruits of PSC 1998 (i.e. Assistant Engineers) is not correct. Their objections are found to be unsustainable and hence the same are rejected.

Sri D.V.Narasimha Rao, A.E. was transferred to Zone-II under GO-610. Hence, his name will be shown in the seniority of Assistant Engineers of Zone-II.

The M.Tech. qualification acquired by Sri P.Chandra Kiran, A.E. is shown against his name.

Further, the Govt. in their Memo No.27234/E.III/A2/2012-4, dt.19.3.2013 have clarified that the date of declaration of result of the test will be taken as the basis for determining the date of commencement of probation. In this regard it is submitted that previously the date of passing of Account test (date of exam held / publication of result in Gazette) as the case may taken as basis for determining the commencement of probation in respect of the A.Es. who have passed Account test belatedly. As per the Govt. instructions and orders the commencement of probation in respect of (35) Asst. Engineers who passed Account test belatedly has been revised vide this office Procs.No.SO.I(2)/5847/2013, dt.20.6.2013 and according to the dates so assigned to them, their placements are shown in the confirmed seniority list in the Annexure enclosed to this memo

The dates of commencement of probation of certain Assistant Engineers of 1994 batch shown in the provisional seniority list dated 4.2.2013 and 15.3.2013 by taking the date of examination as qualifying date for promotion are also revised as per the date of result declared by APPSC to maintain uniformity regarding passing of Account test for PWD Officers and Subordinates and accordingly they are placed at Sl.Nos. from 83 to 85 and 87 to 94 and 97,102,103&118 in the confirmed seniority list of Assistant Engineers of Zone-I enclosed to this memo.

The names of the following Assistant Engineers who were transferred to Zone-II under GO-610 / expired are deleted.
