In compliance to the orders of Hon'ble Courts and orders / instructions of Government, a revised provisional seniority list of Assistant Executive Engineers of Zone-VI covering batches LR-84, PSC-84, GO-413, LR-85, PSC-86, PSC-89, G.O.193 and upgraded Assistant Executive Engineers in supersession of the earlier confirmed seniority list issued vide reference 1<sup>st</sup> & 2<sup>nd</sup> cited and revised combined provisional seniority list communicated vide reference 3<sup>rd</sup> cited, was prepared and communicated by incorporating / deleting the names of Assistant Executive Engineers who were repatriated to Zone-VI from other zones / repatriated to other Zones from Zone-VI under GO-610 and by applying Rule 16 (h) of A.P. State and Subordinate Service Rules 1996 in respect of the Assistant Executive Engineers who passed Account test belatedly vide reference 14<sup>th</sup> cited.

In response to the above, certain individuals have filed objections, which are discussed and disposed off as follows, duly keeping in view of the latest court directions and Government orders.

# 1. M. Rajasekhar Reddy, Executive Engineer, PR Division, Peddapally, Karimnagar Dist.

He has submitted his objection that he was appointed as Assistant Executive Engineer through APPSC in 1986 in Zone-VI with order of merit 8. In the revised provisional seniority list of Assistant Executive Engineers, he was placed at SI.No.56 with date of commencement of probation on 02.10.1987. He further represented that his seniority number should be at 54 instead of 56, since SI.No.54 and 55 candidate's date of commencement is also the same i.e., 02.10.1987 who are also recruited by APPSC in 1986 with order of merit 20 and 22 as shown in the Gazette No.5A, dated.06.02.1986 and requested to consider his objection and place him at SI.No.54 instead of at SI.No.56, since his APPSC order of merit is above them.

### **Remarks:**

As per the list furnished by the APPSC, Sri.M.Rajasekhar Reddy is at Sl.No.8 whereas, Sri.Jagmohan Lal is at Sl.No.20 and Smt.Vinobha Devi is at Sl.No.22, but the name of Sri.M.Rajaseklhar Reddy have been shown below them at Sl.No.56.

Hence, the individual's name is shown above Sri Jagmohan Lal and Smt. Vinobha Devi at Sl.No.54 and Sri.Jagmohan Lal is placed at Sl.No.55 and Smt.Vinobha Devi is placed at Sl.No.56 in the confirmed seniority list of Assistant Executive Engineers of Zone-VI.

### 2. K. Thirupathaiah, Dy. Exe. Engineer, PRI Sub Division, Tandur, R.R. District

He has submitted his objection that in the revised provisional seniority list of Assistant Executive Engineers of Zone-VI, his date of birth (SI.No.75) is mentioned as 16.08.1960. But actually his date of birth is 16.08.1964 and requested to change his date of birth as 16.08.1964. He also enclosed the copies of SSC Marks List, relevant copies of Service Register.

#### Remarks:

His objection is verified with reference to the entry in his service register and found that his date of birth is 16.08.1964.

Hence, the Date of birth of the individual is corrected as 16.08.1964 in the confirmed seniority list of Assistant Executive Engineers of Zone-VI.

### 3. Sri D. Venkata Ramana, Executive Engineer, PR, RWS&S Division, Hyderabad.

He has submitted that in the revised provisional seniority list of Assistant Executive Engineers of Zone-VI his name at SI.No.79 has been mentioned as D.Venkata Ratnam instead of D.Venkata Ramana and his date of commencement of probation has been mentioned as 07.06.1989, whereas his juniors i.e., SI.No.80 & 81, the same was mentioned as 26.04.1989 and requested to change his name and reason for declaration of commencement of probation after the date.

As verified the earlier confirmed seniority list, dated.01.06.2007, his name is as Sri.D.Venkata Ramana.

Regarding the date of commencement of probation as 07.06.1989, the said dates have been taken as was in the confirmed seniority list communicated earlier and it is informed that the date of commencement of probation of Sri.M.Raghu at Sl.No.77 is 07.06.1989 as his date of joining is 07.06.1989. The date of commencement of probation of his juniors is to be restricted to his date of commencement of probation i.e., 07.06.1989. But in the confirmed seniority list and revised provisional seniority lists communicated earlier, the above dates were mentioned.

Hence, the date of commencement of probation of the Assistant Executive Engineers at SI.No.78 to SI.No.103 is corrected as 07.06.1989 and his name is corrected as D.Venkata Ramana in the confirmed seniority list of Assistant Executive Engineers of Zone-VI.

## 4. Sri P.Mruthyunjayam, Executive Engineer, PIU Division, Karimnagar.

He submitted his objection that he was joined in the service on 18.01.1986 as Assistant Executive Engineer and he was placed on probation w.e.f.18.01.1986. He appeared the Account Test for PWD Officers and Subordinates held on 04.01.1991 and passed, the same is published in Gazette No. 4-A, dated. 23.01.1992 and the Government have extended his period of probation in relaxation of rule 24 (C) and 26 of AP State and Subordinate Service Rules vide G.O.Rt.No.1257, dt. 4.11.1992 of PR & RD (Estt.III) Department and kept his date of commencement of probation as 18.01.1996.

He further reported that during November, 1997 & June 2007 confirmed seniority in the category of AEEs was communicated duly considering his date of commencement of probation as 18.01.1986 only. Now a revised provisional seniority list of Assistant Executive Engineer of Zone-VI is communicated duly affecting his seniority with reference to 16 (h) and kept his date of commencement of probation w.e.f.02.10.1989. He further reported that as his period of probation is extended in relaxation of Rule 24 (C) and 26 of APSSS Rules, 1996 and hence his date of commencement of probation can not be changed.

### Remarks:

As per the Government directions vide their memo No. 2025/Estt.II/2009-1, PR&RD Dept, dated. 05.05.2009 and Memo No.27234/Estt.III/A2/2012-4, dated. 19.03.2013, the date of Declaration of results of the Account Test shall be considered for determination of the date of commencement of probation and declaration of probation implementing the rule 16 (h) of AP State & Subordinate Service Rules 1996.

The Hon'ble APAT in their orders dated.03.12.2003 in OA No. 8080/1997 has set aside the G.O.Ms.No.186, PR & RD Dept., dated. 08.04.1996 and stated that it does not take away the rights of the persons, who already passed the tests and got qualified. So, necessarily those, who do not passed the tests within the time, who were given relaxation, have to be considered next to the persons, who have already passed the tests within the prescribed time. It only confers a right on them that they should not be discharged from service and not to confer a right to declare probation from the date of their regular recruitment for not passing the tests, within the time.

In the instance case, it is informed that the orders issued by the Government in respect of the applicant in G.O.Rt.No.1257, dated.04.11.1992 was in relaxation of rules as similar to the common orders issued in the G.O.186, dated.08.04.1996. Since, the said G.O. was set aside by the Hon'ble Tribunal in OA No.8080/1997, dated.03.12.2003, the orders issued earlier to the G.O.186 in respect of the applicant will also have no validity.

As such, his commencement of probation has been revised with reference to the date of passing of account test duly applying penal clause 16(h) of AP State and subordinate service rules 1996, as he passed account test belatedly vide Govt Memo No.27234/Estt.III/A2/2012-5, dated.15.06.2013.

Accordingly, his name has been shown in the revised provisional seniority list of Zone-VI with reference to his revised date of commencement of probation at SI.No.108.

Hence, his objection is rejected.

## 5. Sri D.Vijaya Kumar, Executive Engineer, RWS& Division, Medak.

He submitted his objection that as per rule 6 of the departmental test rules, 1965, the date of publication of results for the tests held on November shall be on or before last Thursday of January. He appeared the November, 1990 exam held on 04.01.1991 and passed the test and as per the above rule, the date of publication of results shall be on 31.01.1991, whereas the results published in the Gazette on  $23^{\rm rd}$  January, 1992 and in the seniority list communicated, the date of passing is taken as 01.10.1991. But as per the test rules, his date of passing cannot be taken beyond 31.01.1991.

He further represented that the Joint Secretary to Government, I&CAD Department has instructed the ENC, I&CAD (AW) to indicate the proposed dates of commencement and declaration of probation against each name as per rule 16(h) rerad with rule 6 of AP Departmental Test Rules to finalised the seniority of Irrigation Department Assistant Executive Engineers and accordingly the Irrigation Department has finalized the seniority list duly adopting Rule 6 of AP Departmental Test Rules.

He further represented that Sri P.A. Venugopal, who belongs to 1986 batch and who appeared exam on 28.06.1991 i.e., later than him was placed before me duly indicating his date of passing of test as 09.09.1989, whereas his date of passing of test taken as 01.10.1989, which is against to natural justice and also shows uniform procedure is not followed and requested to consider the date of passing of test as 31.01.1991 as per rule 6 of AP Departmental Test Rules.

#### Remarks:

As per the Government directions vide their memo No. 2025/Estt.II/2009-1, PR&RD Dept, dated. 05.05.2009 and Memo No.27234/Estt.III/A2/2012-4, dated. 19.03.2013, the date of Declaration of results of the Account Test shall be considered for determination of the date of commencement of probation and declaration of probation implementing the rule 16 (h) of AP State & Subordinate Service Rules 1996.

In the instant case, the individual has appointed through APPSC in the year 1986 and passed account test belatedly during the year 1991. The Date of exam is 04.01.1991 and the date of results published in the Gazette furnished by the APPSC in their letter, dated.01.10.1991. Since the date of publication of results by APPSC is not available, the date of letter of APPSC i.e., 01.10.1991 in which the results details furnished to the Commissioner, Government Printing Press has been taken into consideration instead of the date of Gazette i.e., 23.01.1992 which is after the letter date.

Accordingly, while communicating the revised provisional seniority list of Zone-VI, the date of passing of account is mentioned as 01.10.1991.

In respect of the exam held on 28.06.1991, the APPSC authorities have furnished the date of publication of results as 09.09.1991, whereas they have not furnished the same in respect of the date of exam held on 04.01.1991. So we have taken the date of publication of results of the exam held on 04.01.1991 as 01.10.1991 which is the date of letter of APPSC in which the said particulars furnished to the printing press to publish in Gazette.

The individual has not furnished any proof regarding the date of publication of results of the Account test for PWD Officers and Subordinates held on 04.01.1991 by the APPSC in support of his claim.

Therefore, his objections are rejected.

# 6. Sri P.Y.Ramachandrdam, Executive Engineer, PRI Division, Kothagudem, Khammam Dist.

He submitted his objection that as per rule 26 (a) (2) of Fundamental Rules, in case where the passing of an examination or test confers on a Government servant the title to any right, benefit or concession, such title should be deemed to have accrued on the day following the last day of examination or test which he passed.

He further represented that the Madras High Court has given orders that as per the rule 26 (a) (2) of fundamental rules, if a Government Servant passed the required departmental tests, the accrued right should be decided based on the date of the last examination attended by him and not on the date of publishing the result in the service commission bulletin and in his case, he has appeared departmental test on 04.01.1991 and as per the fundamental rule 26 (a) (2) the date of passing of the test should be as 05.01.1991, but in the seniority list the date of passing is taken as 01.10.1991, which is against the fundamental rules and requested to implement the fundamental rule 26 (a) (2) and consider his date of passing the exam as 05.01.1991 and accordingly his date of commencement of probation shall be taken as 05.01.1989.

## **Remarks:**

As per the Government directions vide their memo No. 2025/Estt.II/2009-1, PR&RD Dept, dated. 05.05.2009 and Memo No.27234/Estt.III/A2/2012-4, dated. 19.03.2013, the date of Declaration of results of the Account Test shall be considered for determination of the date of commencement of probation and declaration of probation implementing the rule 16 (h) of AP State & Subordinate Service Rules 1996.

In the instant case, the individual has appointed through APPSC in the year 1986 and passed account test belatedly during the year 1991. The Date of exam is 04.01.1991 and the date of results published in the Gazette furnished by the APPSC in their letter, dated.01.10.1991. Since the date of publication of results by APPSC is not available, the date of letter of APPSC i.e., 01.10.1991 in which the results details furnished to the Commissioner, Government Printing Press

has been taken into consideration instead of the date of Gazette i.e., 23.01.1992 which is after the letter date.

Accordingly, while communicating the revised provisional seniority list of Zone-VI, his name was placed at appropriate place at SI.No.110 with reference to the revised date of commencement of probation as per penal clause 16 (h) of APSSS rules 1996.

Therefore, his objection is rejected.

# 7. Sri P.Joga Reddy, I/C.Executive Engineer, PIU Division, Wanaparthy, Mahabubnagar Dist

He submitted his objections that:

- a) He appointed as Assistant Executive Engineer and joined duty on 03.03.1989 through APPSC. During the year 1992 he was placed on probation with effect from 01.10.1989 with a direction to pass the Account Test for PWD Officers and Subordinates during the period of probation and accordingly he has passed the account test held on 15.06.1992 as per the APPSC certificate, dated. 22.09.1992. He further reported that during November, 1997 & June 2007 confirmed seniority in the category of Assistant Executive Engineers was communicated duly obtaining objections from the Assistant Executive Engineers, duly placing him above Sri S.Manohar Rao in both the lists. As such there are no objections received from any Assistant Executive Engineers in Zone-VI, the seniority lists were confirmed. Hence, the settled seniority list cannot be altered at this stage after a long gap.
- b) In the Circ. Memo NO.57759/Ser-A/2004-1, dated.20.05.2003 and dated. 20.05.2004 of GAD (Ser.A) Department, the Government has instructed not to consider request for revision of seniority for a period which is more than three years old shall be considered and directed not to open the settled seniority as per Apex Court Judgment.
- c) As per rule 36 of APSS, the seniority of the persons in the service shall be determined (a) in respect of the candidate selected by the APPSC or other selecting authorities by direct recruitment shall be with reference to their ranking assigned irrespective of the date of commencement of their probation in that category and with the above facts, his seniority shall be placed at SI.No. 69 above Sri S. Manohar Rao (now at SI.No. 70 in provisional list) as the penal clause 16 (h) APSSS Rules, 1996 is not applicable to him as he has passed the account test within the prescribed period of probation and consider his objection.

#### **Remarks:**

As per the Government directions vide their memo No. 2025/Estt.II/2009-1, PR&RD Dept, dated. 05.05.2009 and Memo No.27234/Estt.III/A2/2012-4, dated. 19.03.2013, the date of Declaration of results of the Account Test shall be considered for determination of the date of commencement of probation and declaration of probation implementing the rule 16 (h) of AP State & Subordinate Service Rules 1996.

In the instant case, the individual has appointed through APPSC in the year 1989 and passed account test belatedly held on 15.06.1992 and the said results were published by the APPSC on 02.09.1992.

The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/2008 & Batch for implementation of Rule 16 (h) of A.P State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA No.10934/08 & Batch.

As per the confirmed seniority list communicated vide T.O.Memo No.SO.VI(1)/00009/2005, dt.01.06.2007, his date of commencement of probation has been shown as 21.04.1989, but not 01.10.1989, as such he passed account test belatedly and accordingly his date of commencement of probation has been revised with reference to rule 16(h) of APSSS Rules 1996 as 03.09.1990 and placed in the revised provisional seniority list with reference to the said date.

Therefore, his objection is rejected.

### 8. Sri N. Rajanna, Dy. Exe. Engineer, PR (Dismissed from the service).

The SE, PR, Anantapur has reported that the name of Sri N. Rajanna, Dy. Executive Engineer was deleted from the revised provisional seniority list on the ground that the officer is dismissed from the service and moreover the account test details are not available. He now submitted that Sri N. Rajanna, Dy. Executive Engineer has passed Account Test held on 16.09.1982 and the individual was dismissed in the cadre of Dy. Executive Engineer and requested to consider the objection and the name of the above individual included in the seniority list of Assistant Executive Engineers of Zone-VI in appropriate place.

#### Remarks:

As verified the Confirmed seniority list communicated vide reference 1<sup>st</sup> cited and revised provisional seniority list of Assistant Executive Engineers of Zone-VI, communicated vide reference 3<sup>rd</sup> cited, Sri N. Rajanna who was appointed through PSC -1984 was placed above Sri.N.Ram Mohan Rao and at the time of communication of revised provisional seniority list duly implementing 16 (h) of AP State and Subordinate Service Rules, 1996, his name was deleted as the Account Test details of the individual are not available and he was dismissed from the service in the cadre of Assistant Executive Engineer.

Now the Superintending Engineer, PR, Anantapur has submitted the Xerox copy of AP Gasette No. 37-B, dated. 16.09.1982, through which the individual has passed the Account Test held on 14.05.1982 and he was dismissed from service in the category of Deputy Executive Engineer.

In view of the above, the name of Sri N. Rajanna, Assistant Executive Engineer, PR of Zone-VI is placed at Sl.No.1 i.e., above Sri.N.Ram Mohan Rao with reference to his date of commencement of probation in the confirmed seniority list of Assistant Executive Engineers of Zone-VI.

# 9. Sri D. Venkateswarlu, Executive Engineer, RWS&S Divison-I, Nalgonda. He submitted his objections that:

- 1) His date of commencement of probation and declaration of probation in the cadre of Assistant Executive Engineer cannot be revised after lapse of over two decades.
- 2) His seniority in the cadre of Assistant Executive Engineer and Dy. Executive Engineer was already confirmed and the same can not be revised after lapse of six years and 4 years respectively.
- 3) The Orders of Hon'ble APAT pertaining to the claim of individual belongs to Zone-V and the same can not be applied in Zone-VI.
- 4) He is not the respondent in the OAs filed by Sri K. Raghuveera Reddy and the orders of APAT were delivered without taking his counter argument and it is not in his knowledge, hence, the orders of Hon'ble APAT cannot be applicable in his case.
- 5) No candidate has submitted any objection with reference to my seniority either in the cadre of Assistant Executive Engineer and Dy. Executive Engineer and hence his seniority cannot be revised since no objection is filed before the competent authority.
- 6) His seniority in the cadre of Assistant Executive Engineer and Dy. Executive Engineer was already settled and based on the settled seniority, he has already got two promotions hence, at this stage the revision of his seniority in the initial cadre is irregular and against rules and it is nothing but invitation of unnecessary complication in the administration.

### **Remarks:**

As per the Government directions vide their memo No. 2025/Estt.II/2009-1, PR&RD Dept, dated. 05.05.2009 and Memo No.27234/Estt.III/A2/2012-4, dated. 19.03.2013, the date of Declaration of results of the Account Test shall be considered for determination of the date of commencement of probation and declaration of probation implementing the rule 16 (h) of AP State & Subordinate Service Rules 1996.

The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/2008 & Batch for implementation of Rule 16 (h) of A.P State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA

No.10934/08 & Batch. The implementation of rule 16 (h) is for all who passed account test belatedly, but not to any one in the department.

In the instant case, the individual has appointed through APPSC in the year 1989 and passed account test belatedly on 21.08.1995. As such he has not found his place in the revised provisional seniority list and his seniority will be communicated separately duly placing him at the appropriate place in the next batches.

Hence, his objections are rejected.

The names of the following officers working in PR/RWS&S who have passed account test belatedly, will be placed at appropriate places in the next batches, as they are attracting Rule 16(h) due to which they have not found place in the confirmed list.
