In compliance to the orders of Hon'ble Courts and orders / instructions of Government, a revised provisional seniority list of Assistant Executive Engineers of Zone-III covering batches LR-84, PSC-84, GO-413, PSC-86, PSC-89 and upgraded Assistant Executive Engineers in supersession of the earlier confirmed seniority list issued vide references $1^{\rm st}$ & $2^{\rm nd}$ cited and combined revised provisional seniority list communicated vide reference $3^{\rm rd}$ cited, was prepared and communicated by incorporating / deleting the names of Assistant Executive Engineers who were transferred to Zone-III from other zones / transferred to other Zones from Zone-III under GO-610 and by applying Rule 16 (h) of A.P. State and Subordinate Service Rules 1996 in respect of the Assistant Executive Engineers who passed Account test belatedly vide reference $11^{\rm th}$ cited.

In response to the above, certain individuals have filed objections, which are discussed and disposed off as follows, duly keeping in view of the latest court directions and Government orders.

1. Sri K.Shiva Kumar, Dy.E.E., PR, V&QC, Markapur, Prakasam Dist.

He has submitted his objection that he has acquired M.Tech. Degree from IIT, Madras University and requested to mention the same against his name instead of B.E.

Remarks:

His objection is examined and corrected his qualification as M.Tech. and mentioned against his name.

2. V. Suresh Kumar, Dy. E.E., PRISD, Chirala, Prakasam Dist.

He has submitted his objection that he passed the Account Test for PWD Officers & Subordinates held in November, 1990 and the results have been announced in AP Gazette-4-A on Thursday 23.01.1992. He stated that in the Seniority List of Assistant Executive Engineers (Zone-III) communicated it is wrongly communicated that he has passed the Account Test on 01.10.1991 instead of 01.11.1990 and requested to rectify the date of passing of Account Test as 01.11.1990.

Remarks:

As per the Government directions vide their memo No. 2025/Estt.II/2009-1, PR&RD Dept, dated. 05.05.2009 and Memo No.27234/Estt.III/A2/2012-4, dated. 19.03.2013, the date of Declaration of results of the Account Test shall be considered for determination of the date of commencement of probation and declaration of probation implementing the rule 16 (h) of AP State & Subordinate Service Rules 1996, in respect of those who passed account test belatedly. The individual has appointed through APPSC in the year 1986 and passed account test belatedly during the year 1991. The exam held on 04.01.1991 and the date of results published in the Gazette No.4-A, dated. 23.01.1992 furnished by the APPSC in their letter, dated.01.10.1991.

Accordingly, while communicating the revised provisional seniority list of Zone-III, the date of passing of account of the individual is mentioned as 01.10.1991.

Therefore, his objection is rejected.

- 3. A. Rajendra Prasad Achari, Dy. EE, PRI SD, Vemuru, Guntur Dist.
- 4. G. Brahmaiah, Dy. EE, PR, V&QC SD, Guntur
- 5. T. Jaya Prasad, Dy. E.E., PR, O/o. ENC, PR, Hyd.

The officers have objected in regarding to revising their commencement of probation due to application of Rule 16(h) of A.P. State and Subordinate Service Rules and contended that the rule is not applicable to them since the condition of passing of Account test within the period of probation was not stipulated in their appointment order and requested to continue the present adopting integrated seniority.

Remarks:

The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/2008 & Batch for implementation of Rule 16 (h) of A.P State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA No.10934/08 & Batch. The Govt. have also issued instructions from time to implement Rule 16(h) and also prepare the seniority strictly in accordance with said rule and review the promotions as per the revised seniority lists. Accordingly, the seniority is revised and communicated in terms of rule 16(h) of APSSS Rules. An individual on his entering into the service is expected to know the rules of the Dept. and it is need not to mention in the appointment order.

Further, the relaxation orders issued by the Govt. in G.O. 186, dt.8.4.1996 were set-aside by the Hon'ble Courts. The Govt. in Memo No.10097/

Estt.III/A2/2012-3, dt.6.5.2013 of PR&RD Dept. have instructed to comply with the orders of Hon'ble Tribunal and to prepare the seniority list by implementing the rule 16(h) of A.P. State and Subordinate Service Rules 1996 within the stipulated time ignoring other aspects.

Therefore, their objections are rejected.

6. P.Vidya Sagar, Dy.E.E., PR, O/o. ENC, PR, Hyd.

The officer has objected

- (a) in regard to revising his commencement of probation due to application of Rule 16(h) of A.P. State and Subordinate Service Rules and contended that the rule is not applicable to him since the condition of passing of Account test within the period of probation was not stipulated in his appointment order and requested to continue the present adopting integrated seniority.
- (b) He further objected that certain Limited Recruitment Assistant Executive Engineers of other zones are re-allotted and placed above him under G.O. 610 and informed that there was no recruitment during 1985 under limited recruitment, since there were no vacancies in Zone-III and hence, if they have to be placed above him and they have to be re-allotted to the zone along with post in the category duly deducting post in the erstwhile zone. Thus occurrence of vacancies in Zone-III will be increased and our due seniority will not be affected.

Remarks:

(a) The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/2008 & Batch for implementation of Rule 16 (h) of A.P State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA No.10934/08 & Batch. The Govt. have also issued instructions from time to implement Rule 16(h) and also prepare the seniority strictly in accordance with said rule and review the promotions on he revised seniority lists. Accordingly, the seniority is revised and communicated in terms of rule 16(h) of APSSS Rules. An individual on his entering into the service is expected to know the rules of the Dept. and it is need not to mention in the appointment order.

Further, the relaxation orders issued by the Govt. in G.O. 186, dt.8.4.1996 were set-aside by the Hon'ble Courts. The Govt. in Memo No.10097/ Estt.III/A2/2012-3, dt.6.5.2013 of PR&RD Dept. have instructed to comply with the orders of Hon'ble Tribunal and to prepare the seniority list by implementing the rule 16(h) of A.P. State and Subordinate Service Rules 1996 within the stipulated time ignoring other aspects.

(b) Regarding certain Assistant Executive Engineers of other zones who were appointed under limited recruitment are placed above him, it is to inform that during repatriation of Assistant Executive Engineers of other zones to their local cadre as per G.O. 610, their seniority has to be protected and placed at the appropriate places as per their date of commencement of probation in their appointed zone from which they were transferred and also as per para (c) (v) of rule 38 of

A.P.S.S.Rules 1996, the seniority of any member of the service who is so transferred on administrative grounds shall be fixed in the unit to which he is transferred with reference to the date of his appointment in the office from which he is transferred. As such, they were placed in the seniority list at appropriate place with reference to their commencement of probation in their appointed zones and as per their commencement of probation as per rule 16 (h) of A.P.S.S.S.Rules 1996

Therefore, his objections are rejected.

7. Sri J.Hare Rama Krishna, Dy.E.E., P, Kandukuru, Prakasam Dist.

The Officer has objected that

- a) He was joined in the department in the month of Jan/Feb (PSC-85) and appeared the departmental test conducted on 28.11.1988 within probation/extended period (three years) and passed the exam but the results were published by the APPSC in the month of April, 1989 and for the delay in declaring results by APPSC, he can not be penalized and requested to exempt us from imposing Rule 16 (h). He further reported that rule 16 (h) was implemented in other State Government departments like I&CAD, R&B and PH and they have considered the date of exam in which the individual has passed the departmental test, but not the date of declaration of results.
- b) It is further reported that as per rule 26 (a) (2) of Fundamental Rules, if a Government Servant passed the required departmental tests, the accrued right should be decided based on the date of the last examination attended by him and not on the date of publishing the result in the service commission bulletin.

Remarks:

As Government directions per the vide their memo No. 2025/Estt.II/2009-1, PR&RD Dept, dated. 05.05.2009 No.27234/Estt.III/A2/2012-4, dated. 19.03.2013, the date of Declaration of results of the Account Test shall be considered for determination of the date of commencement of probation and declaration of probation as per rule 16 (h) of AP State & Subordinate Service Rules 1996.

Therefore, his objections are rejected.

8. Sri Ch. Chenchu Ramaiah, Dy. Exe. Engineer, PR PRI SD, Kanigiri, Prakasam Dist.

The officer objected that

he joined duty on the FN of 17.06.1989 and the Chief Engineer, (Technical & Administration) was placed him on probation w.e.f. 06.07.1989 FN during the year 1997 and issued instructions to pass the Account Test for PWD officers & Subordinates within the prescribed period of probation. He further represented that there is gap of (8) years in between his appointment orders and placing of probation orders. It is further reported that he immediately passed the Account Test during the year 1998 and as per para 18 of AP State and Subordinate Service Rules, 1996, any lapses are noticed during the period of probation by the appointing

authority, should be communicated to the probationer, to rectify the lapses. But he has not been received any thing.

Remarks:

The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/2008 & Batch for implementation of Rule 16 (h) of A.P. State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA No.10934/08 & Batch. The Govt. have also issued instructions from time to implement Rule 16(h) and also prepare the seniority strictly in accordance with said rule and review the promotions as per the revised seniority lists. Accordingly, the seniority is revised and communicated in terms of rule 16(h) of APSSS Rules. An individual on his entering into the service is expected to know the rules of the Dept. and it is need not to mention in the appointment order.

It is further informed that Sri Ch. Chenchu Ramaiah, was appointed through LR -89 and he passed the Account Test for PWD Officers & Subordinates on 28.10.1998. As per Government Memo No. 27234/E.III/A2/2012-4, dated. 19.03.2013 of PR & RD (E.III) Department, his date of commencement of probation is 29.10.1996 and his name was not covered in the revised provisional seniority list communicated on 03.06.2013, as the date of commencement of probation of the individual is after 25.04.1992 (PSC -92 batch).

Therefore, his objection is rejected

Further it is informed that the following individuals who are working in PR/RWS&S as the case may be, were deleted from the list since they have passed Account Test belatedly and attracting Rule 16(h) and they have not found place in the list now communicated and their seniority will be communicated separately duly placing them at the appropriate places in the next batches.

Administrative Tribunal / High Court of Andhra Pradesh / Supreme Court of India.
