The provisional seniority list of graduate Deputy Executive Engineers of Zone-VI has been communicated for the panel years from 1975-76 to 1999-2000 vide reference 6<sup>th</sup> cited with reference to the confirmed seniority list of Assistant Executive Engineers of Zone-VI vide reference 5<sup>th</sup> cited and carry forwarding all the Deputy Executive Engineer vacancies meant for Direct recruitment from the panel years 1983-84 to 1998-99 i.e., up to the Service rules issued in G.O.Ms.No.15, PR&RD (Estt.II) Department, dated.08.01.1999 and released as on the date of the said G.O.

In response to the above, certain Engineering officers have filed objections, which are discussed and disposed off as follows.

### 1) SRI.B.SURENDER REDDY, CE (RWS&S)

## **Objection I:**

He has requested to examine his case in light of rule positions and true facts by re-fixing his seniority above Sri R Chakrapani who joined in the department on 14.11.1986 and also passed account test belatedly on 18.06.1993 and issue necessary revised orders duly considering three years seniority and place him in the appropriate panel year.

#### Remarks:

It is informed that Sri.R.Chakrapani was appointed through APPSC (Direct Recruitment) in the cadre of Deputy Executive Engineer. Government vide their Memo No.127174/Estt.I/82-9, dated.12.06.1984 of PR&RD Department, have permitted him to resume duty as Deputy Executive Engineer after the special leave petition is decided by the Hon'ble Supreme Court of India and his seniority will be regulated in terms of rule 33 (b) of General Rules. Further, the Government vide G.O.Ms.No.6, PR&rD (Estt.III) Department, dt.05.01.1990, have regularized the services of Sri.R.Chakrapani w.e.f.14.11.1986 i.e., from the date of his joining duty as Deputy Executive Engineer along with all Direct recruited Deputy Executive Engineers under rule 5 (a) of the Special Rules for the A.P.PRES read with General Rule 23 (a) of the State and Subordinate Service Rules and the said date is for the

purpose of regularization of his services and the APPSC ranking as assigned above shall be maintained for the purpose of seniority with in the zone. Accordingly, the ranking and seniority will not be disturbed in respect of Sri.R.Chakrapani.

Moreover, Sri.B.Surender Reddy has filed OA No.2414/2013 seeking direction to suspend the confirmed seniority list of DEE published in A.P.Gazette NO.91, dated.04.12.2009 questioning the placement of Sri.R.Chakrapani as per the date of joining and rule 16 (h) which is still pending in the Hon'ble Tribunal.

Since, the matter is subjudice, objections rejected. Any correction required will be made as per the out come of the court case.

#### **Objection II:**

He has requested that Sri R.Jagan Mohan may be placed in the panel year 1985-86, since he joined in Zone VI on mutual request transfer and hence he should be placed in the last of that panel year i.e 1985-86 as per the rules in vogue.

#### Remarks:

It is informed that he was initially appointed as Deputy Executive Engineer in Zone-II and later he was joined in Zone-VI under mutual transfer vide G.O.Ms.No.406, dated.09.04.1984. His services were regularized in Zone-VI w.e.f.04.02.1983 vide G.O.Ms.No.6, dated.05.01.1990 and his probation has been declared w.e.f.03.02.1985 AN vide G.O.Ms.No.544, dated.25.10.1993.

Since, his services had been regularized in Zone VI w.e.f.04.02.1983 after his transfer from Zone-II to Zone-VI under mutual grounds, his name has been placed in the Revised Provisional Seniority list of graduate Deputy Executive Engineers of Zone VI with reference to the said date during the panel year 1982-83.

Hence, his objection rejected.

#### **Objection III:**

In the light of amends to service rules, at this point of carry forward direct DEE's vacancies up to 1998-99 panel is unconstitutional against the natural Justice. Hence revise list by allowing vacancies as all previous ENC prepared list.

#### Remarks:

Since, the request has come from all zones, it is accepted.

#### 2) SRI.G.ANIL, DEE (PR)

#### **OBJECTION:**

Rule of Reservation not implemented to fill up Arose vacancies due to repatriations *under G0.610*.

Please place my name i.e. 6.ANIL, *AEE* of zone VI belong to scheduled caste at *S. no* . 89 instead of 111 in place of 3. Sudarshan Rao who is at *S. No.* 89 in the confirmed seniority list of *Asst.* Executive Engineers of Zone VI, and accordingly fix my notional dates of commencement of probation by showing the actual date of joining as a bEE and reckoning date of seniority as a DEE by implementing the Rule of reservation & filling up the above arose 4 vacancies in respect of 15% scheduled castes of zone VI and also in the combined integrated seniority lists of Panchayat Raj Engineering wing at the earliest possible.

### Remarks:

The rule 33 (b) of A.P.State and subordinate Service Rules speaks that the order of merit or order of preference indicated in a list of selected candidates prepared by the Public Service Commission or other selecting authority, shall not be disturbed inter-se with reference to the candidates position in such list or panel while determining the seniority in accordance with this rule and notional dates of commencement to the probation to the extent necessary shall be assigned to the persons concerned, with reference to the order of preference assigned to them in the said list.

G.O.Ms.No.2, Social Welfare (SW.ROR1) per Department, dated.09.01.2004, the reservation in promotions shall be implemented in favour of Scheduled Castes and Scheduled Tribes, in all categories of posts in all state Government Departments, if they are not adequately represented to the extent of 15% and 6& respectively. The crucial date for implementing the rule of reservation in promotions shall be 14.02.2003 i.e., the date of issue of G.O.Ms.No.5, Social Welfare (SW.ROR1) Department, Dated.14.02.2003. The panels for the year 2002-03 which were prepared prior to 14.02.2003 and operated totally or partially, shall continue without any changes and they shall not be reopened. The panels for the year 2002-03, which were prepared and are not operated as on 14.02.2003 shall have to be reviewed to implement the rule of reservation in promotion to Scheduled Caste and Scheduled Tribe categories.

In this regard it is informed that even though some of the employees pertains to certain APPSC batch, repatriated from one zone to another zone, the replacement with another employee of the same APPSC batch with same community which is nothing but disturbing the merit or order of preference indicated in a list prepared by the APPSC. But as per APSSS rules, the order of merit or order of preference indicated in a list of selected candidates prepared by the APPSC or other selecting authority shall not be disturbed.

It is further submitted that the as per G.O.Ms.No.2, Social Welfare (SW.ROR1) Department, dated.09.01.2004, the rule of reservation has been introduced w.e.f.14.02.2003 in promotions only, if the panels for the year 2002-03 was not operated, the same is to be reviewed to implement the rule of reservation

to SC and ST categories. If operated, the same may be implemented from the panel year 2003-04.

In the instant case, the name of the individual is placed in the panel year 1997-98 which is prior to the introduction of rule of reservation in promotion. The rule of reservation in promotions will be implemented as per the G.O.Ms.No.2, Social Welfare (SW.ROR1) Department, dated.09.01.2004.

Hence, his objection is rejected.

## 3) SRI.V.SWAMY, I/C EE (PR)

**Objection:** Direct Recruitment to the post of Deputy Executive Engineer from the panel years 1984-85 to the date of new service rules issued. Vide G.O.Ms. No.15, PR&RD (Estt.II) Dept., Dt.08.01.1999.

In the seniority list of DEEs of zone-VI communicated vide ref.  $1^{\rm st}$  cited. Now it is decided to carry forward the vacancies every year meant for direct recruitment post of Deputy Executive Engineers from the panel year 1983-84 to 08.01.1999 and to release all the said carry forward vacancies as on the date of issue of G.O.15. Dt:08.01.1999.

Through ref. 3<sup>rd</sup> cited, direct recruitment to the post of Deputy Executive Engineer abolition orders issued. Hence, it is requested to consider the carry forward of direct DEE posts and all the said vacancies may be taken up to 20.11.1995 instead of 08.01.1999. Accordingly, we humble request the Engineer-in-chief, to communicate the modified seniority of Graduate DEEs duly accommodating in suitable panel years up to 1994-95 instead of in 1998-99. (G.O.Ms. No. 305. Copy enclosed).

## **Remarks**:

Since, the request for not to carry forward the Direct Recruitment vacancies of Deputy Executive Engineers and to fill up as was done in the earlier confirmed seniority list of Deputy Executive Engineers and same is accepted.

## 4) SRI.P.JOGA REDDY, I/C EE (PR)

#### Objection:

It is to submit my objections on the basis that clause 16(h) of APSSS Rules, 1996 is not applicable to me as I have passed the Accounts Test with in the prescribed period of probation as per the orders vide references (1&3) cited above (copies enclosed).

Even if the date of publication of results is also considered i.e. 02.09.1992 clause 16(h) of ASPSSS Rules, 1996 is not applicable to me on the following facts shown below:

1. My date of commencement of probation was with effect from 01.10.1989 as per Proc.No.G3/19590/90 dt:25.09.1992 of Engineer-in-Chief, PRED, Hyderabad (Copy enclosed).

- d) Revisions in the number of vacancies in the Dy. EEs' Rank in all zones & no discussion made in the pre-amble to the provisional lists now communicated.
- i) Unsettling the already settled seniority list and notified by the Govt of Andhra Pradesh vide"The Andhra Pradesh Gazette Part-VII Extraordinary No. 91 dt: 04<sup>th</sup> Dec., 2009" without quoting the appropriate authorities under which the review is being made.

#### Remarks:

It is informed that the Hon'ble Tribunal in C.A. No. 1577 of 2012 in OA. No.3293 of 2009 and C.A.No,1911 of 2012 in OA.No. 8080 of 1997 filed by Sri K.Raghuveera Reddy DEE (PR) zone-V have passed orders to prepare the seniority list duly implementing the rule 16 (h) and G.O.610 repatriations. Accordingly Government have issued necessary instructions to revise the seniority lists and also keeping in view of the orders of the Hon'ble Tribunal, dated.29.06.2011 in OA No.1079/2008 and 1082/2008, to implement the upgradation without weightage from 1987 i.e., from the date on which the service rules are amended in respect of the AEEs upgraded in terms of G.O.MS.No.552, dated.16.05.1978 and G.O.Ms.No.662, dated.24.11.1987, subject to outcome of the WPs pending in the Hon'ble High Court of AP, if any on the subject matter. As such the seniority lists are now being revised.

During the course of revision of seniority lists, it is found necessary to recast the vacancies of Deputy Executive Engineers for the reasons as follows:

- 1) Some of the vacancies were shown in the earlier list due to the retirement of Deputy Executive Engineers promoted from the feeder category of Assistant Engineers, but some of them will not come into the zone of consideration even for promotion to the post of Deputy Executive Engineer before their retirement.
- 2) The upgraded Assistant Executive Engineers during the years 1978 to 1987 were previously covered in the graduate Deputy Executive Engineers list during the panel years from 1982-83 to 1992-93 and their DEE vacancies were shown in the earlier list due to their promotion as Executive Engineer. Now, as per Court/Government orders, they have brought down and placed them in the seniority list of AEES as on 24.11.1987 due to which they are now covered in the graduate DEEs seniority list in the panel year 1997-98. As such, some of them will not come into the zone of consideration for promotions to the post of Executive Engineer up to the panel years covered in the seniority list communicated.

Hence, objections are rejected.

#### **Objections:**

c) On noticing a change in the Date of Regularization as DEE in the lists now communicated.

#### Remarks:

It is informed that the provisional seniority list of DEEs communicated by carry forwarding the direct recruitment vacancies, as such, the change in the date of regularization was taken place. But now, it is decided to confirm the said seniority list without carry forwarding the DR vacancies due to which there is no change in the date of regularization and the date of regularization in the earlier confirmed list and present list is 30.06.1997. Accordingly his objection is disposed.

- 2. Date of passing of account test fro PWD officers & subordinated was on 15.06.1992 and publication of results was on 02.09.1992 as per APPSC Certificate No.2319/DTA/2/92 dt:22.09.1992 (copy enclosed).
- 3. Date of completion of probation period was on 16.06.1992 (A/N) as per the Proc.No.G3/13797/92 ft:08.01.1994 of Engineer-in-Chief, PRED, Hyderabad (Copy enclosed). Even if the date of publication of results i.e. 02.09.1992 is taken my period of passing of account test will not cross the permitted prescribed period of probation of below 3 years.

In view of the above facts he has requested to consider his above objections and restore his original place in the seniority list of Graduate Dy. Executive Engineer, and place him below Sri U.Satyanarayana Murthy (now at Sl.No.129 in provisional List).

### Remarks:

As per the revised Confirmed Seniority list of Assistant Executive Engineers of zone-VI communicated vide this office Memo No.SOVI)1)00009/2005, dated.01.06.2007, The date of commencement of probation of Sri.P.Joga Reddy, Assistant Executive Engineer was 21.04.1989 and his date of passing of account test is 02.09.1992 due to which he attracts the rule 16 (h) of A.P.State and Subordinate Service rules 1996. As such, his date of commencement of probation had been revised as 03.09.1990 and communicated the confirmed seniority list of AEEs of Zone-VI with reference to the said date which is in accordance with rules.

Based on the confirmed seniority list of AEEs, communicated vide this office Memo., dated.15.10.2013, the provisional seniority list of graduate Deputy Executive Engineers of Zone-VI duly considering his name with reference to the placement in the confirmed seniority list of AEEs of zone VI has been communicated, which is in accordance with rules.

Hence, his objection rejected.

### 5) SRI.S.RAMA KRISHNA, DEE (PR)

## Objection:

a) For not looking into/considering the objections filed by me vide ref.(4) cited on the provisional lists of AEEs communicated vide ref. (3) cited

### Remarks:

It is informed that the objections against the revised provisional seniority list of Assistant Executive Engineers of Zone-VI said to have been submitted on 10.10.2013 was received in this office on 17.10.2013 which is after communicating the confirmed seniority list of AEEs of zone VI, dated.15.10.2013. However, after examining the objections in detail, the said objections have been disposed off vide this office Memo No.Ser.VI(2)/00009/2005, dated.04.11.2013.

## **Objections:**

b) For causing revisions in the number of vacancies panel year wise in the Dy. EEs' Rank in all zones w/o any reference to any court orders.

## **Objections:**

e) The ENC, PR is requested to communicate the total list of DEEs (with names) in all the Zones including those promoted through other feeder channels

#### Remarks:

It is informed that as per the earlier service rules, there was a separate channel for promotion to the post of Executive Engineer from the post of Deputy Executive Engineer who were promoted from the feeder categories, i.e., Assistant Executive Engineer and Assistant Engineer/DM Grade.I. As per existing service rules, there is no channel for promotion to the post of Executive Engineer from the Deputy Executive Engineers promoted from Assistant Engineer/DM Grade.I. However, the seniority list of Deputy Executive Engineers promoted from the feeder categories of Assistant Engineer/DM Grade.I may be communicated to the concerned in due course.

Hence, his objection disposed accordingly.

## Objection:

f) For not deleting the names of upgraded AEEs' from the lists now communicated in spite of clear directions from Hon'ble APAT in O.A 1079/2008 & 1082/2008

#### Remarks:

It is informed that as per the orders issued in G.O.Ms.No.552, dated.16.05.1978, certain Assistant Engineers of Zone-VI were upgraded during the years 1978 to 1987 against the vacancies of AEEs and they were later promoted as DEE and there on based on the confirmed seniority list of AEEs/DEEs. The said executive orders were amended in G.O.Ms.No.662, dated.24.11.1987.

The Government in their Memo No.10097/Estt.III/A2/2012-6, dated.17.09.2013 of PR&RD Department, have issued orders keeping in view of the orders of the Hon'ble Tribunal, dated.29.06.2011 in OA No.1079/2008 and 1082/2008, to implement the upgradation without weightage from 1987 i.e., from the date on which the service rules are amended in respect of the AEEs upgraded in terms of G.O.MS.No.552, dated.16.05.1978 and G.O.Ms.No.662, dated.24.11.1987, subject to outcome of the WPs pending in the Hon'ble High Court of AP, if any on the subject matter.

Accordingly, the names of AEEs upgraded in terms of G.O.Ms.No.552, dated.16.05.1978 to the date of amendment issued in G.O.Ms.No.662, dated.24.11.1987 have been placed in the seniority list of AEEs of Zone-VI at appropriate place with reference to the date of G.O.i.e,, 24.11.1987.

Hence, his objection is rejected.

## Objection:

g) on the seniority being fixed on the basis of Roster Points in the rank of DEEs' but not on the merit of marks obtained in the written examination of the recruiting agency i.e., APPSC

#### Remarks:

It is informed that the rule 33 (b) of A.P.State and subordinate Service Rules speaks that the order of merit or order of preference indicated in a list of selected candidates prepared by the Public Service Commission or other selecting authority,

shall not be disturbed inter-se with reference to the candidates position in such list or panel while determining the seniority in accordance with this rule and notional dates of commencement to the probation to the extent necessary shall be assigned to the persons concerned, with reference to the order of preference assigned to them in the said list.

As such, the seniority of the Assistant Executive Engineers is as per the list furnished by the APPSC which is in accordance with rules.

Hence, his objection is rejected.

## **Objections:**

h) The manner in which seniority is being unduly given to the individuals who have been repatriated from other zones to Zone VI under the G.O.Ms. No: 610

#### Remarks:

It is informed that Sri.P.Y.Ramchandram, Sri.M.Ashok Reddy and Mohd Abdul Samee are pertains to PSC 1986 batch were repatriated from other zones to Zone-VI on public interest as provided under para 5 (2) © of the Presidential Order, as such they are eligible for protection of seniority. Accordingly, their names have been placed in the seniority list of Assistant Executive Engineers of Zone-VI with reference to their batch of appointment and date of commencement of probation.

Hence, his objection is rejected.

#### 6) SRI.K.THIRUPATHAIAH AND (06) OTHER DEEs (PR)

### Objections:

- (a): For not looking into/considering the objections filed by us vide ref.(4) cited on the provisional lists of AEEs communicated vide ref.(3) cited
- (b): For causing revisions in the number of vacancies panel year wise in the Dy. EEs' Rank in all zones w/o reference to any court orders .
- $\circledcirc$  For not deleting the names of upgraded AEEs' from the lists now communicated in spite of clear directions from Hon'ble APAT in O.A 1079/2008 & 1082/2008
- (e):The manner in which seniority is being given unduly to the individuals who have been repatriated from other zones to Zone VI under the GOMs No: 610.
- (f): Unsettling the already settled seniority list and notified by the Govt of Andhra Pradesh vide "The Andhra Pradesh Gazette Part-VII Extraordinary No. 91 dt: 04<sup>th</sup> Dec., 2009" without quoting the appropriate authorities under which the review is being made.

## Remarks:

It is informed that the similar objections have been raised by Sri.S.Rama Krishna, DEE PR and the same are disposed off as above at Sl.No.5.

#### Objection:

(d) <u>Deletion of dismissed</u>, absconded, expired and resigned AEEs from the provisional seniority list of AEEs of Zone-VI and as done in Zone-V.

#### Remarks:

It is informed that the names of certain AEEs who were shown in the revised confirmed seniority list of AEEs of Zone-VI, communicated in this office Memo No.Ser.VI(1)/00009/2005, dated.15.10.2013 as absconded, expired, dismissed and resigned were covered in the earlier confirmed seniority lists of zone VI, dated.01.06.2007. Moreover, out of 9 Engineers as indicated by him, the names of 8 Engineers except Sri.N.Dayanand Mathews were covered in the earlier confirmed seniority list of graduate DEEs of Zone-VI communicated in this office Memo No.DI(4)/1807/2008-Zone.6, dated.27.11.2009. Since, all of them are approved probationers in the cadre of AEE and all of them except one AEE, were already promoted as DEE and as such their names can not be deleted from the seniority list of AEEs of Zone-VI.

It is informed that the request has come from all zones not to carry forward the vacancies of Deputy Executive Engineers meant for Direct Recruitment from the panel year 1983-84 to 1998-99 and to consider it as was done in the earlier confirmed seniority list of graduate Deputy Executive Engineer list communicated vide reference 3<sup>rd</sup> cited. After examining the issue in detail, it is decided to confirm the seniority list of graduate Deputy Executive Engineers without carry forwarding the vacancies of Deputy Executive Engineers meant for Direct Recruitment from 1983-84 panel years.

Therefore, the Revised Provisional Seniority list of graduate Deputy Executive Engineers, PR of Zone-VI communicated from the panel years 1975-76 to 1999-2000 (Out of 9 vacancies available for graduate DEEs of Zone-VI during the panel year 1999-2000, only two graduate DEEs are communicated due to non availability of candidates) vide reference 6<sup>th</sup> cited is hereby finalized duly rejecting/accepting various objections and confirmed as shown in the Annexure enclosed to this memo subject to outcome of O.As./W.Ps./S.L.Ps., if any pending, before the Hon'ble A.P. Administrative Tribunal / High Court of Andhra Pradesh / Supreme Court of India.
