The seniority lists of Assistant Executive Engineers of LR-84, PSC -86 PSC-LR-89 and G.O. 413 and upgraded batches in Zone-III (2 lists) have been confirmed without examining the penal clause 16(h) of AP State Subordinate Service Rules in respect of individuals those who have passed Account Test belatedly and communicated vide references 1st & 2nd cited.

Consequently, in terms of orders issued vide G.O.Ms.No.388 PR&RD Department, dated.12-11-2010 and as per the instructions issued in Memo.No.1140/Estatt.III/A2/2011 PR&RD Department Dt. 09-03-2011, a combined revised provisional seniority list of Zone-III Assistant Executive Engineers covered in the above 2 lists has been prepared and communicated to all the affected individuals duly calling their objections, if any, on the ranking assigned to them vide reference 3rd cited. The list was not confirmed due to pending of court cases. Meanwhile the Hon'ble Tribunal has passed final orders on 12.04.2013 in OA No. 11459/09 and batch cases, setting aside the G.O.Ms.No.388, PR & RD (E.III) Dept., dated. 12.11.2010 and consequential proceedings issued in pursuance of the said Government Orders and directed the respondents to regularize the services of temporarily appointed Assistant Executive Engineers of 1987-88 in accordance with G.O.Ms.No.193, dated.14.03.1990 alone. Further directed to issue one final/integrated seniority list of Assistant Executive Engineers of Zone-VI for PSC selected Assistant Executive Engineers and also temporarily appointed Assistant Executive Engineers, in pursuance of G.O. Ms.No.193, dated.14.03.1990 and then issue common seniority list in the cadre of Dy. Executive Engineers and consider the various Assistant Executive Engineers/Deputy Executive Engineers for promotion to the next cadre in accordance with the seniority list so prepared.

Vide reference 9th & 10th cited the Govt., have revised the date of commencement of probation in respect of the Assistant Executive Engineers, who have passed Account Test belatedly and who attracted the penal clause 16(h) of AP state and Subordinate Service Rules-1996 and requested for taking further necessary action. Accordingly, the commencement of probation and declaration of probation of the Assistant Executive Engineers, who passed Account Test belatedly have been revised vide reference 11th cited.

The name of Sri.M.Rajasekhar Reddy, who appointed as AEE through APPSC, 1986 was placed in the earlier seniority lists communicated vide reference 1st & 3rd cited as per the Government orders issued in Govt., Memo No.79308/Esst.III/91-5, dated.10.02.1993 of PR&RD (Esst.II) Department to treat the probation period commencing from 11.10.1988 i.e., the date on which he has rejoined duty, as his absence period from 17.01.1988 to 10.10.1988 was treated as DIES NON vide G.O.Rt.No.1205, PR&RD (Esst.III) Department, dated.09.09.1988. Later the said dies non period has been treated as leave/coumpulsory wait i.e., from 17.01.1988 to 11.07.1988 as EOL in relaxation of rule 23 (a) (ii) of AP leave rules, 1933 and from 12.07.1988 to 10.10.1988 as compulsory wait and directed the ENC, PR to take necessary action as per rule 16(h) of APSSS rules, 1996 for declaration of probation and fix his seniority at appropriate place as per rules/instructions/orders in force vide G.O.Rt.No.1743, PR&RD (E.III) Department, dated.22.11.2011. Accordingly, necessary proposals of Sri.M.Rajasekhar Reddy, i/c EE along with others have been submitted to Government vide reference 7th & 8th cited and the Government have issued orders of revising dates of commencement of probation and declaration of probation vide reference 9th & 10th cited and the ENC PR Hyderabad vide reference 11th cited, have issued orders of commencement of probation w.e.f.02.10.1987. As such, his name is now placed at appropriate place with reference to his revised date of commencement of probation.

In supersession of the revised provisional seniority list communicated in the reference 3rd cited and in pursuance of the Government orders issued in the reference 9th & 10th cited, a revised provisional seniority list is prepared and annexed to this memo.

The following individuals now working as SEs/EEs/DEEs, etc. as the case may be, whose names covered in confirmed Seniority lists communicated vide reference 1st and 2nd cited and later communicated revised provisional seniority list duly combining (2) lists vide reference 3rd cited, who are under orders of repatriation to their local zones under SPF rules and in pursuance of the orders issued by the Govt., are hereby deleted from the list now communicated.
