In the reference 1<sup>st</sup> cited, the provisional seniority list of Assistant Executive Engineers of PSC-92, upgraded & LR-95 batches in Zone-III have been communicated without examining the penal clause 16(h) of AP State Subordinate Service Rules in respect of individuals those who have passed Account Test belatedly and communicated and G.O. 610.

As per rule 16(h) of AP State and Subordinate services rules, 1996 a probationer who does not pass the prescribed test or acquire the prescribed special qualification within the period of probation or within the extended period of probationer rule (17) and whose probation is extended by Government by an order under rule 31 till the date of his passing of such test. Shall be deemed to have been commenced the probation W.E.F the date to be fixed by Government, which would be anterior to a date to his passing such test or acquiring such special qualification, so however, that the interval between the two dates shall be equivalent to the prescribed period of probation, whether on duty or otherwise and seniority of such probation shall be determined in the reference to the date so fixed. The said rule shall be applicable to the individuals those appointed or joined after 9<sup>th</sup> March, 1981 and whose seniority in the said class, category or grade shall be fixed under sub-rule (b) of Rule 33, prior to the said date."

The Hon'ble High Court in batch of Writ petitions No.22978, 23404, 23093, 16801, 17219, 17315, 17340, 16897, 16807 and 23101 of 2008 with respect to Rule 16(h) of A.P. State and Subordinate Service Rules has issued common orders dated 18.12.2008 stating that in view of clear and categorical expression of rule 16(h) that notwithstanding anything contained in Special Rules or Sub-Rules (a) and (b) of Rule 33 of General Rules, Rule 16(h) will over ride any provisions under the Special Rules.

Further, the Hon'ble APAT in O.A.No.10934/2008, O.A.No.6500/2006 and batches has issued common order on 27.2.2009 as follows:

"In rule 16(h) of A.P. State and Subordinate Service Rules power is given to change the date of commencement of probation.

To be more clear, Rule 16(h) reads as follows:

"16(h) change of date of commencement of probation.

Notwithstanding anything contained in the Special Rules or sub-rules (a) and (b) of Rule 33, a probationer who does not pass the prescribed test or acquire the prescribed special qualifications within the period of probation or within the extended period of probation under Rule 17 and whose probation is further extended by the Government by an order under Rule 32, till the date of his passing such tests or acquiring such qualifications shall be deemed to have commenced the probation with effect from the date to be fixed by the Government, which would be anterior to a date of his passing such tests or acquiring such special qualifications, so, however, that the interval between the two dates shall be equivalent to the prescribed period of probation, whether on duty or otherwise and seniority of such probationer shall be deemed with reference to the date so fixed.

Provided that nothing in this sub-rule shall apply in the case of persons appointed to the class, category or grade in a service prior to the 9<sup>th</sup> March, 1981 and whose seniority in the said class, category or grade was fixed under sub-rule (b) of Rule 33, prior to the said date."

The Government vide Memo No. 2025/Estt.II/2009-1, PR&RD Dept. dt. 5.5.2009 have issued instructions that the date of publication of results shall be taken for the purpose of declaration of probation of individual and two years anterior to the date of commencement of probation and seniority of such probations shall be determined with reference to the dates so fixed by following the penal provision contained in the Rule 16(h) of the A.P. State and Subordinate Service Rules 1996.

In view of the Court orders and instructions issued by the Government, from time to time, it is necessary to revise the seniority lists communicated therein duly following penal clause 16 (h) of APSSS Rules, 1996 in respect t of the Asst. Exe. Engineers who have passed Account test belatedly along with the repatriations who have joined in Zone-III as per G.O. 610.

Vide reference 11<sup>th</sup> cited the Govt., have revised the date of commencement of probation in respect of the Assistant Executive Engineers (PSC-92 & GO-262 batch), who have passed Account Test belatedly and who attracted the penal clause 16(h) of AP state and Subordinate Service Rules-1996 and requested for taking further necessary action. Accordingly, the commencement of probation and declaration of probation of the Assistant Executive Engineers, who passed Account Test belatedly have been revised vide reference 12<sup>th</sup> cited.

In supersession of the orders issued in the reference 1<sup>st</sup> cited and in pursuance of the Government orders issued in the reference 11<sup>h</sup> cited, a revised provisional seniority list of Asst. Executive Engineers is now prepared on the following lines.

- 1. That the DEEs/Asst. Executive Engineers who were repatriated to their respective local cadre shall be treated as DEE/AEEs of their local zone to which they were repatriated.
- 2. That the placement of DEE/AEEs repatriated to their local zones shall be placed below the DEE/AEEs of the same batch (both APPSC and Temporary recruitments)
- 3. That the date of regularization shall be taken for giving placement among the section officer repatriated from various zones to one particular local zone of same batch (Both APPSC and Temporary recruitment)

The following (3) Asst. Exe.Engineers, now working as SE/EE/DEEs, etc., as the case may be, whose names were not covered in the earlier confirmed seniority lists communicated vide reference 7<sup>th</sup> & 8<sup>th</sup> cited, due to passing of Account test belatedly, have been included duly placing them at the appropriate place as per their date of commencement of probation in the cadre of Asst. Exe. Engineer.
