The provisional seniority list of Assistant Executive Engineers of 1992 PSC batch in Zone-VI was communicated vide reference 1<sup>st</sup> cited and the provisional seniority list of AEEs of Zone-VI pertains to LR 1993, UK-1990, CERP-1991 and LR-1995 batches was communicated vide reference 2<sup>nd</sup> cited without examining the penal clause 16(h) of AP State Subordinate Service Rules in respect of individuals those who have passed Account Test belatedly and without implementing the repatriations as per G.O.610.

Vide reference 4<sup>th</sup> cited, the Government have revised the date of commencement of probation and declaration of probation in respect of the Assistant Executive Engineers, who have passed Account Test belatedly and who attracted the penal clause 16(h) of AP state and Subordinate Service Rules-1996. Accordingly, the commencement of probation and declaration of probation of the Assistant Executive Engineers, who passed Account Test belatedly have been revised vide reference 5<sup>th</sup> cited.

Sri.K.Shyamsunder and M.Vinatha have been appointed by transfer as Assistant Executive Engineer w.e.f.15.03.1992 and 23.03.1992 vide references 7<sup>th</sup> and 8<sup>th</sup> cited respectively. Aggrieved by the above action, certain AEEs of PSC 1992 batch have filed OAs before the Hon'ble Tribunal and the Hon'ble Tribunal in its common order, dated. 09.09.2003 in OA No.6223/02 with VMA Nos.421/02, 422/02 and 418/02, OA No.2923/02 with VMA Nos.417/02 and 423/02, OA No.2878/2002 with VMA No.416/02 that the OAs deserved to be allowed and they are accordingly allowed by setting aside the impugned G.O.Rt.No.1583, dt.04.10.2001 and G.O.Rt.No.1584, dated.04.10.2001 and the consequential Memo., dated.06.12.2001 of the ENC, PR, Hyderabad.

In view of the above orders, they have approached the Hon'ble High Court of Andhra Pradesh, Hyderabad against the Hon'ble Tribunal orders, dated.09.09.2003 and the issue is still pending in the Hon'ble High Court of Andhra Pradesh. As such their names are placed in the seniority list with reference to their date of appointment by transfer as Assistant Executive Engineer vide references 7<sup>th</sup> & 8<sup>th</sup> cited.

Vide reference 10<sup>th</sup> cited, certain Assistant Executive Engineers of PSC 92 batch of Zone-VI have submitted their objections against the appointment by transfer of Sri.S.Bhasker Rao, from the next date of joining in the department on his transfer from Ground Water Department vide reference 9<sup>th</sup> cited. Their objections will be examined along with other objections received if any and now his name is placed in the provisional seniority list with reference to the date of appointment by transfer vide reference 9<sup>th</sup> cited.

In supersession of the provisional seniority lists communicated in the references 1<sup>st</sup> & 2<sup>nd</sup> cited and in pursuance of the Government orders issued in the references 4<sup>th</sup> & 7<sup>th</sup> to 9<sup>th</sup> cited, a revised provisional seniority list is prepared and annexed to this memo.

The following individuals now working as EEs/DEEs, etc. as the case may be, whose names covered in provisional seniority lists communicated vide reference 1<sup>st</sup> and 2<sup>nd</sup> cited, who were repatriated to their local zones under SPF rules and in pursuance of the orders issued by the Govt., are hereby deleted from the list now communicated.
