## ORDER:

The Hon'ble High Court of A.P. and A.P.A.T., Hyderabad have delivered judgments on implementation of 16 (h) of AP State and Subordinate Service Rules, 1996 in respect of Assistant Executive Engineers those who passed Account Test belatedly. Accordingly, the Government have issued instructions from time to time to implement the rule 16 (h) of APSSS, 1996 and requested the Engineer-in-chief, PR to revise the date of commencement of probation in respect of Assistant Executive Engineers, who passed Account Test belatedly and also to revise the seniority with reference to the revised date of commencement of probation.
