The provisional seniority list of graduate Deputy Executive Engineers of Zone-I has been communicated for the panel years from 1975-76 to 2001-2002 vide reference 5<sup>th</sup> cited with reference to the confirmed seniority list of Assistant Executive Engineers of Zone-I vide references 3<sup>rd</sup> and 4<sup>th</sup> cited and carrying forward all the Deputy Executive Engineer vacancies meant for Direct recruitment from the panel years 1983-84 to 1998-99 i.e. up to the Service rules issued in G.O.Ms.No.15, PR&RD (Estt.II) Department, dated.08.01.1999 and released as on the date of the said G.O.

In response to the above, certain individuals have filed objections which are discussed and disposed off as follows.

I) Sri K. Venkateswarlu, Dy.E.E., O/o SE,RWS&S,Srikakulam

## Gist of the objection:

He has submitted his objection that he was sponsored to study M.Tech. through department and has completed M.Tech. with distinction from JNTU, Hyderabad in 2011 (2009-11) batch and he was senior to the following AEEs. as per ranking of APPSC 1986 and as per the date of commencement of probation.

- 1. Sri V.Srinivasa Rao
- 2. Sri M.Nagaraju
- 3. Sri V.Ravikumar

But in the seniority list of AEEs, all the above officers who are juniors to him have also acquired M.Tech. qualification and they are placed above him duly taking into consideration of their PG qualification. It is not so done in his case. Hence, objected and requested to place him at a position of higher rank than the above three engineers taking into consideration of his PG qualification.

#### Remarks:

His case for promotion to the post of Dy.E.E. under PG point could not be considered against the vacancies arose prior to acquisition of his PG qualification. He acquired PG qualification later than his juniors. Hence his name could not com up for consideration against the PG point. Therefore his juniors in the category of AEE have become seniors to him in the cadre of Dy.E.E. Hence, his objection is rejected.

## Gist of the objection:

Both the above individuals have submitted their objection that they belongs to PSC 1986 batch A.E.Es. and attended Account test for PWD Officers and Subordinates held on 20.11.1988 within the probation period allowed by the Govt. The results declared by APPSC were published in A.P. Gazette in the month of April 1989. They contended that contrary to the protection given under FR 26 applicable to State Govt. employees and unlike other major Engg. Depts. In the Govt. of Andhra Pradesh, they were penalised by the department regarding their seniority in the cadre of AEE and their names were placed at the end of PSC batch 1986 of Zone-I due to wrong interpretation of rule 16(h) of A.P. State and Subordinate Service Rules. They have stated that they have already given representation to that effect. Further they have requested for praying consideration of Hon'ble APAT interim relief and their objections.

### Remarks:

It is informed that though the examination held on 26.11.1988 the results were declared by APPSC on 12.04.1989. As per rules in vogue the date of passing of Departmental Test for PWD Officers and Subordinates is the criteria for determining the date of commencement of probation but not the date of examination held. The same was already informed while confirming the seniority of A.E.Es. of Zone-I

Further, the Govt. in Memo No.27234/Estt.III/A2/2012-8, dt.24.09.2013 of PR&RD Dept. have clarified that the date of publication of result shall be taken for declaration of probation, seniority, promotion etc. Hence, the date of publication of results would be taken as basis for determining the date of commencement of probation and declaration of probation.

### Gist of the objection:

All the above officers have submitted their objections that duly contending that the posts of Dy.E.Es. meant for direct recruitment are carried forward from the panel year 1983-84 upto the panel year 1998-99. But all the posts were already filled by promotions from the feeder categories in respective panel years from the last (15) years, those posts were not kept vacant and channel for recruitment to these posts were also removed. They contended that carrying forward the (15) years

backlog posts i.e. posts pertains to panel years from 1983-84 to 1998-99 to the single panel year i.e. 1998-99 is extremely objectionable. Further, contended that some of them who acquired M.Tech. qualification have also lost their PG point in Dy.EEs. seniority and pushing down in the seniority.

#### Remarks:

The similar objections have come from all zones not to carry forward the vacancies of Deputy Executive Engineers meant for Direct Recruitment from the panel year 1983-84 to 1998-99 and to consider it as was done in the earlier confirmed seniority list of graduate Deputy Executive Engineer list communicated vide reference 3<sup>rd</sup> cited. After examining the issue in detail, it is decided to confirm the seniority list of graduate Deputy Executive Engineers without carrying forward the vacancies of Deputy Executive Engineers meant for Direct Recruitment from 1983-84 panel years.

Therefore, the Revised Provisional Seniority list of graduate Deputy Executive Engineers (PR) of Zone-I communicated from the panel years 1975-76 to 2001-02 vide reference 5<sup>th</sup> cited is hereby finalized duly rejecting/accepting various objections and confirmed as shown in the Annexure enclosed to this memo subject to outcome of O.As./W.Ps./S.L.Ps., if any pending, before the Hon'ble A.P. Administrative Tribunal / High Court of Andhra Pradesh / Supreme Court of India.
