The seniority lists of Assistant Executive Engineers of SQT, LR 79 and GO 647 batches including the upgraded Assistant Executive Engineers was confirmed and communicated vide reference 1<sup>st</sup> cited. The seniority list of Assistant Executive Engineers of LR-84, PSC -86 PSC-LR-89 and G.O. 413 and upgraded batches in Zone-VI have been confirmed by implementing the penal clause 16(h) of AP State Subordinate Service Rules in respect of individuals those who have passed Account Test belatedly and those who had been repatriated under GO.610 and communicated vide references 2<sup>nd</sup> cited.

Sri.Y.Bhagyaraju, & 05 others have filed OA No.1079/2008 and Sri.K.Amarnath Reddy & (11) others have filed OA No.1082/2008 questioning the G.O.662, dated.24.11.1987 in which the upgradation as AEE has been given retrospective effect from the date of executive instructions issued in GO.No.552, dt.06.05.1978.

The Hon'ble Tribunal has passed final orders on 29.06.2011 in OA No. 1079/2008 and OA No.1082/2008 filed by Sri.Y.Bhagyaraju & (05) others and Sri.K.Amarnath Reddy & (11) others respectively as follows:

"Having regard to the facts and circumstances obtaining in these case and by taking into consideration the orders rendered by this Tribunal in OA No.8350/1989, dted.07.10.2005 and the judgment in the case of U.Govinda Rao Vs Govt. of AP reported in 2002 (1) ALD 347, the impugned Memo Note No.D1(4)/8119/2007-Zone-IV, dt.08.01.08, Memo No.D1(4)/1807/2008-Zone-4, dated.04.12.09 and Memo No.SO.IV(1)/50597/2005-Zone-IV-1, dated.02.06.2007 have no legs to stand and they are accordingly, set aside. There shall be a direction to the respondents to delete the names of the unofficial respondents and others Assistant Executive Engineers from the seniority list and to prepare the seniority list afresh."

In view of the above, necessary proposals have been submitted to the Government seeking necessary clarification in the matter vide reference 3<sup>rd</sup> cited and accordingly, the Government vide reference 4<sup>th</sup> cited, has agreed the proposals of the ENC, PR to implement the upgradation without weightage from 1987 i.e., from the date on which the service rules are amended, in respect of the AEEs upgraded in terms of G.O.Ms.No.552, PR&RD (Estt.III) Department, dated.16.05.1978 and G.O.Ms.No.662, PR&RD (Estt.III) Department, dated.24.11.1987. The Government have requested the ENC, PR to take further action accordingly in the matter, subject to outcome of the WPs pending in the Hon'ble High Court of AP, if any, on the subject matter, duly maintaining status quo in respect of the Petitioner in WP.No.10356/2004 and by following due procedure.

As per the confirmed seniority lists of Assistant Executive Engineers of Zone-VI communicated vide references 1<sup>st</sup> and 2<sup>nd</sup> cited in which the following (15) number of Assistant Executive Engineers PR of Zone-VI who were upgraded have been placed before 24.11.1987 i.e., before issue of amendment to service rules.

In view of the above, the said (15) upgraded AEEs, PR of Zone.VI who were placed in the seniority lists above 24-11-1987 i.e., after issue of executive orders in G.O.Ms.No.552, dated.06.05.1978 and before amendment of service rules issued in the G.O.662, dated.24.11.1987, are now brought down by giving the date of commencement of probation as 24-11-1987 which is date of GO in which service rules were amended and placed them with reference to the said date, duly maintaining status quo in respect of the Petitioners in WP.No.10356/2004.

The name of Sri.K.Chippa Ramanna is shown at Sl.No.102 in the confirmed seniority list of Zone-VI communicated vide reference 2<sup>nd</sup> cited stating that he has been repatriated from Zone-IV to Zone-VI. But it is noticed now that he has not been repatriated to Zone-VI and presently working in Zone-IV only. As such, his name is now deleted from the seniority list of Assistant Executive Engineers of Zone-VI.

Sri.P.A.Venugopal who has been repatriated to Zone-VI from Zone-V as per GO 610 was passed account test held on 28.06.1991, belatedly and the said results were published by the APPSC on 09.09.1991. The said results were published in Gazette No.47A, dated.02.11.1993 and as such his name has been shown in the confirmed seniority list of Assistant Executive Engineers of Zone-VI at Sl.No.106. But the names of the following Assistant Executive Engineers of Zone-VI were passed account test held on 04.01.1991, belatedly and the said results were published in the Gazette No.4A, dated.23.01.1992.

In the absence of the date of publication of results by the APPSC in respect of the said 5 AEEs, we have taken the date of letter by the APPSC to Government Printing Press i.e., 01.10.1991 as the basis. It is logical to keep the batch officers who passed account test held on 04.01.1991, belatedly, above Sri.P.A.Venugopal who passed account test held on 28.06.1991, belatedly and results of which published on 09.09.1991. As such, the names of the said officers are now shown above Sri.P.Venugopal by giving the date of passing of account test as 09.09.1991, duly giving the date of commencement of probation of the said 5 officers as 10.09.1989.

The list now communicated is only provisional and will be finalized after examining the objections if any received from the individual concerned.

The Assistant Executive Engineers who are placed in the revised provisional seniority list are requested to file their objections, if any, within (10) days from the date of receipt of this memo against their proposed ranking in the revised provisional seniority list duly substantiating their stand with recorded proof, since the Hon'ble Tribunal have give time for finalization of seniority lists up to 28.10.2013 only, failing which, it will be construed that they have no objections against their placements in the provisional seniority list and further action will be taken to confirm the provisional seniority list. Any objections filed after the stipulated time will not be entertained. They are requested to acknowledge the receipt of this memo.

The seniority list now communicated is subject to final outcome of O.As./W.Ps./SLPs., if any, pending in the Hon'ble Courts.
