It is submitted that in the references 1<sup>st</sup> to 4<sup>th</sup> cited, Provisional Seniority Lists of Assistant Executive Engineers appointed through APPSC-1992 and LR-1993, temporary batches and along with upgraded in Zone-V has been communicated without implementing the SPF Rules and also without applying the penal clause 16(h) of AP State Subordinate Service Rules in respect of individuals those who have passed Account Test belatedly .

Further, as per rule 16(h) of AP State and Subordinate services rule 1996 a probationer who does not pass the prescribed test or acquire the prescribed special qualification within the period of probation or with in the extended period of probationer rule (17) and whose probation is extended by Government by an order under rule 31 till the date of his passing of such test, shall be deemed to have been commenced the probation W.E.F the date to be fixed by Government, which would be anterior to a date to his passing such test or acquiring such special qualification, so however, that the interval between the two dates shall be equivalent to the prescribed period of probation, whether on duty or otherwise and seniority of such probation shall be determined in the reference to the date so fixed. The said rule shall be applicable to the individuals those appointed or joined after **09-03-1981** and whose seniority in the said class, category or grade shall be fixed under sub-rule (b) of Rule 33, prior to the said date."

The Hon'ble High Court in batch of Writ petitions No.22978, 23404, 23093, 16801, 17219, 17315, 17340, 16897, 16807 and 23101 of 2008 with respect to Rule 16(h) of A.P. State and Subordinate Service Rules has issued common orders dated 18.12.2008 stating that in view of clear and categorical expression of rule 16(h) that

notwithstanding anything contained in Special Rules or Sub-Rules (a) and (b) of Rule 33 of General Rules, Rule 16(h) will over ride any provisions under the Special Rules.

Further, the Hon'ble APAT in O.A.No.10934/2008, O.A.No.6500/2006 and batches has issued common order on 27.2.2009 as follows:

"In rule 16(h) of A.P. State and Subordinate Service Rules power is given to change the date of commencement of probation.

To be more clear, Rule 16(h) reads as follows:

"16(h) change of date of commencement of probation.

Notwithstanding anything contained in the Special Rules or sub-rules (a) and (b) of Rule 33, a probationer who does not pass the prescribed test or acquire the prescribed special qualifications within the period of probation or within the extended period of probation under Rule 17 and whose probation is further extended by the Government by an order under Rule 32, till the date of his passing such tests or acquiring such qualifications shall be deemed to have commenced the probation with effect from the date to be fixed by the Government, which would be anterior to a date of his passing such tests or acquiring such special qualifications, so, however, that the interval between the two dates shall be equivalent to the prescribed period of probation, whether on duty or otherwise and seniority of such probationer shall be deemed with reference to the date so fixed."

Provided that nothing in this sub-rule shall apply in the case of persons appointed to the class, category or grade in a service prior to the 9<sup>th</sup> March, 1981 and whose seniority in the said class, category or grade was fixed under sub-rule (b) of Rule 33, prior to the said date."

The Government vide Memo No. 2025/Estt.II/2009-1, PR&RD Dept. dt. 05.05.2009 have issued instructions that the date of publication of results shall be taken for the purpose of declaration of probation of individual and two years anterior to the date of commencement of probation and seniority of such probationers shall be determined with reference to the dates so fixed by following the penal provision contained in the Rule 16(h) of the A.P. State and Subordinate Service Rules 1996.

In the references 13<sup>th</sup> cited the Government have issued orders to implement the up-gradation without weightage from 1987 i.e. from the date on which the service rules amended in respect of Assistant Executive Engineers upgraded in terms of G.O. 552 PR&RD(Estt-III) Department Dated. 16-05-1978 and G.O. 662 PR&RD(Estt-III) Department Dated. 24-11-1987 and the Government also instructed the Engineer-In-Chief (PR) Hyderabad to take necessary further action accordingly in this matter after affording an opportunity of representation to the affected parties subject to outcome of the WPs pending in the Hon'ble High Court of AP if any on the subject matter duly maintaining status quo in respect of the petitioners in WP No. 10356/2004 and by following due procedure.

In view of the Court orders and instructions issued by the Govt., from time to time vide references 6<sup>th</sup> and 12<sup>th</sup> cited it is necessary to revise the seniority lists communicated therein duly following Penal Clause of 16(h) of APSSS Rules -1996 in respect of the A.E.Es those who have passed Account Test belatedly along with the repatriations who have joined in Zone-V as per G.O. 610.

In super cession of the orders issued therein and in pursuance of the Govt., orders and in continuation of this office confirmed Seniority List of Assistant Executive Engineers vide reference 15<sup>th</sup> cited a revised provisional seniority list of Assistant Executive Engineers is prepared on the following lines.

- 1) that the DEEs/Assistant Executive Engineers who were repatriated to their respective local cadre shall be treated as DEE/A.E.E.s of their local Zone to which they were repatriated.

- 2) that the placement of DEE/A.E.E.s repatriated to their local Zones shall be placed below the DEE/A.E.E.s of the same batch (both APPSC and Temporary recruitments)
- 3) that the date of regularization shall be taken for giving placement among the Sections Officer repatriated from various Zones to one particular local Zone of same batch (both APPSC and Temporary recruitment)

The Deputy Executive Engineers/Assistant Executive Engineers as the case may be who have attracted Rule 16(h) of APSSS Rules-1996 and whose names not covered in the earlier Seniority lists due to passing of Account Test belatedly and communicated vide references 9<sup>th</sup> cited has been carry forwarded now and their names may be included duly placing them at the appropriate places as per the date of commencement of probation in the cadre of Assistant Executive Engineer which is restricted to 14-09-1994 i.e. the date of commencement of probation of Temp-1994.

The Government have issued orders to implement the up-gradation without weitage from 1987 i.e. from the date on which the service rules amended in respect of Assistant Executive Engineers upgraded in terms of G.O. 552 PR&RD(Estt-III) Department Dated. 16-05-1978 and G.O. 662 PR&RD(Estt-III) Department Dated. 24-11-1987 and after affording an opportunity of representation to the affected parties subject to outcome of the WPs pending in the Hon'ble High Court of AP if any on the subject matter duly maintaining the status quo in respect of the petitioners in WP No. 10356/2004 and by following due procedure.

In view of the above instructions, now, it is necessary to revise the lists communicated therein duly following the instructions of the Government in respect of the individuals those who were upgraded to the post of Assistant Executive Engineer in terms of orders issued in G.O. 662 Dt 24-11-1987.

However, in O.A.No. 6071 of 2004 and 6034 of 2004, O.A.No. 1741 2007 and the Hon'ble APAT have issued orders to maintain the status quo in respect of the following individuals on their date Commencement of probation except Sri. CH.Sudhakar Assistant Executive Engineer (upgraded).
