In compliance to the orders of Hon'ble Courts and orders / instructions of Government, a revised provisional seniority list of Assistant Executive Engineers of Zone-I covering batches PSC-83, LR-84, PSC-84, GO-413, PSC-86, PSC-89 and upgraded AEEs. in supersession of the earlier confirmed seniority list issued vide reference 1st cited, was prepared and communicated by incorporating / deleting the names of A.E.Es. who were transferred to Zone-I from other zones / transferred to other Zones from Zone-I under GO-610 and by applying Rule 16 (h) of A.P. State and Subordinate Service Rules 1996 in respect of the AEEs. who passed Account test belatedly vide reference 10th cited.

In response to the above, certain individuals have filed objections, which are discussed and disposed off as follows, duly keeping in view of the latest court directions and Government orders.

I Sri M.Rajeswara Rao, SE,RWS&S,Nalgonda

Gist of the objection:

He has submitted his objection that in his appointment order no condition like passing of Account test for PWD officers and Subordinate and language test within the probation period. Due to lack of information from the appointing authority he could not attend the Account test. Further, the Govt. in G.O.Ms.No.186, dt.8.4.1996 have issued orders relaxing General rule 26 & 24(c) of Service Rules and commencing the probation w.e.f. the date of joining. He has requested to make the G.O. 186 applicable to at least those who have not been intimated due to delay in submission of antecedents to pass the Account test in the initial service i.e. upto probation period of (2) years for the batches of 1985 and 1986. If the Hon'ble Supreme Court do not accept the procedure regarding the intimation to pass Account test at the initial service probation during the course of arguments, his placement may be fixed as per the judgement of the Apex court which is awaited. He has objected the seniority and requested to continue the presently adopting integrated seniority.

Remarks:

The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/2008 & Batch for implementation of Rule 16 (h) of A.P State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA No.10934/08 & Batch.

Further, the relaxation orders issued by the Govt. in G.O.No.186, dt.8.4.1996 was set-aside by the Hon'ble Courts. The Govt. in Memo No.10097/Estt.III/A2/2012-3, dt.6.5.2013 of PR&RD Dept. have instructed to comply with the orders of Hon'ble Tribunal and to prepare the seniority list by implementing the rule 16(h) of A.P. State and Subordinate Service Rules 1996 within the stipulated time ignoring other aspects.

Accordingly, the seniority is revised and communicated in terms of rule 16(h) of APSSS Rules. Therefore, his objection is rejected.

II Sri K.Venkateswarlu, Dy.E.E.,O/o SE,RWS&S,Srikakulam**Gist of the objection:**

He has submitted his objection that he has acquired M.Tech. Degree from JNTU and requested to mentioned the same against his name instead of B.E. Further he requested to correct his name as K.VENKATESWARLU.

Remarks:

His objection is examined and corrected his name as K.VENKATESWARLU and his M.Tech. qualification is mentioned against his name.

III Sri R.Ramam, Dy.E.E., PRI Subdvn., Pathapatnam**Gist of the objection:**

He has submitted his objection stating that his date of birth is erroneously mentioned as 01.10.1954 instead of 01.10.1964 and requested to rectify the same.

Remarks

His objection is examined and his date of birth is corrected as 01.10.1964.

IV 1. Sri R.Kusuma Bhaskar, Dy.E.E.,PRI Sub-dvn., Bhemili**2. Sri M.V.N.Venkata Rao, Dy.E.E., PIU Sub-dvn., Saluru****Gist of the objections:**

Both the officers have submitted their objections that they joined in the Dept. on 17.1.1986 and appeared Account test for PWD Officers and Subordinates held on 26.11.1988 within the probation period and passed the exam. But the results were declared in the month of April 1989 (i.e. beyond 3 years of probation period). They have also stated that for the delay in declaration of result by APPSC, they cannot be penalised and requested to exempt them from imposing rule 16(h) and also stated that the I&CAD Dept. has taken the date of examination held is criteria for determining the commencement of probation and requested to follow the same analogy in P.R. Dept.

Remarks:

They are informed that though the examination held on 26.11.1988 the results were declared by APPSC on 12.04.1989. As per rules in vogue the date of passing of Departmental Test for PWD Officers and Subordinates is the criteria for determining the date of commencement of probation but not the date of examination held. Hence, their objections are rejected.

V Sri K.Jawhar Kumar, Dy.E.E., RWS, Parvathipuram**Gist of the objection:**

He has submitted his objection that he was exempted from repatriation to Zone-II and retained in Zone-I vide G.O.Ms.No.58, PR&RD(E.III)Dept., dt.21.2.2009 and requested to include his name in the seniority list of A.E.Es. of Zone-I at appropriate place.

Remarks:

On verification of records it is found that he was exempted from repatriation orders and retained in Zone-I. Hence, his name is shown in the confirmed seniority list of A.E.Es. of Zone-I w.r.t. his date of commencement of probation.

VI 1. Sri S.Ranadev, Dy.E.E., PIU Sub-dvn., Paderu
2. Sri K.M.V.Prasada Rao, Dy.E.E., PIU Sub-dvn., Sompeta

Gist of the objections:

Both the officers have objected in regarding to revising their commencement of probation due to application of Rule 16(h) of A.P. State and Subordinate Service Rules and contended that the rule is not applicable to them since the condition of passing of Account test within the period of probation was not stipulated in their appointment order and requested to continue the present adopting integrated seniority.

Remarks:

The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/2008 & Batch for implementation of Rule 16 (h) of A.P State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA No.10934/08 & Batch. The Govt. have also issued instructions from time to time to implement Rule 16(h) and also prepare the seniority strictly in accordance with said rule and review the promotions. Accordingly, the seniority is revised and communicated in terms of rule 16(h) of APSSS Rules. An individual on his entering into the service is expected to know the rules of the Dept. and it is need not to mention in the appointment order.

Therefore, their objections are rejected.

VII Sri P.Krishna Reddy, Dy.E.E.(PR) OD in RVM(SSA)**Gist of the objection:**

He has objected that he was shown as belated in the seniority. He has stated that he passed Account test for PWD Officers and Subordinates held on 12.6.1987 and the same was published in A.P. Gazette on 24.12.1987. He has enclosed Xerox copy of Gazette. He also stated that he passed the Account test for PWD Officers and Subordinates within the prescribed period of his probation and requested to rectify the same.

Remarks:

His objection is examined and found that he passed Account test for PWD Officers and Subordinates with in the period of his probation. Accordingly, his placement in the seniority is restored w.r.t. his date of commencement of probation.

VIII Sri B.Venkata Rao, Dy.E.E., PIU Sub-dvn., Sabbavaram**Gist of the objection:**

He has represented that he was upgraded as AEE from the category of AE in Procs.No. G.4/32075/75, dt.3.9.1987 of CE, PR&Genl., Hyderabad and he is entitled for weightage of service as per the Single bench judgment dt.2.5.2007 in C.A. 1712-13/2002 of the Hon'ble Supreme Court of India. Therefore the present revised provisional seniority list without giving weightage of service is objectionable and violative of Hon'ble Supreme Court Judgment.

He has further represented and requested to mentioned his ME qualification in the seniority duly enclosing Xerox copy of M.E. Degree.

Remarks:

In view of the orders of Hon'ble APAT in O.A.No.8350/97, 7883/97, 9800/ 2001, 1243/2002 and in W.P.No.18154/2004, W.P.No.1793/ 2004, W.P.No.434/2004 and W.P.No.10356/2004 and as per the judgment of Hon'ble Supreme Court of India in G.S. Venkat Reddy and others case, the upgraded A.E.Es. are placed in the seniority list at appropriate places w.r.t. their date of appointment and without weightage and below the last regular candidate treating them on par with regularised who were temporary.

Further, the Hon'ble APAT in its judgment dated 29.6.2011 in O.A.No.1079/2008 and 1082/2008 has observed that the Govt. have issued executive instructions in G.O.Ms.No.552, dt.16.5.1978 providing a channel of appointment to those Supervisors (now A.Es.) after acquiring Degree qualification. Subsequently the Govt. introduced amendments vide G.O.Ms.No.662, dt.24.11.1987 to the Special Rules and the supervisors are made eligible to be appointed as A.E.Es. subject to availability of vacancies. It cannot be construed that the A.Es are entitled to be appointed as A.E.Es. automatically for appointment, there must be vacancy available. Furthermore, the amendments have also provided for seniority to the A.Es. appointed by transfer as A.E.Es. Since the amendment to the service rules issued in G.O.No.662, dt.24.11.1987, the A.Es. upgraded as A.E.Es. before amendment to the service rules are not eligible for appointment to the post of A.E.E. and directed the respondents to delete the names of the upgraded A.E.Es. from the seniority list and to prepare the seniority list afresh.

Sri B.Venkata Rao, was upgraded as A.E.E. based on the executive instructions issued in G.O.Ms.No.552, dt.16.5.1978 vide Procs.No.G.4/32075/75, dt.3.9.1987 of C.E, PR&Genl.,Hyd. i.e. before issue of amendment in G.O.Ms.No.662, dt.24.11.1987.

As per the Hon'ble APAT judgment dated 29.6.2011 in O.A.No.1079/2008 and 1082/2008 his name has to be deleted from the seniority list of A.E.Es. of Zone-I.

Keeping in view of the judgement in O.A.No.1079/2008 and 1082/2008 of the Hon'ble APAT the Government have been addressed for instructions in the matter. Pending receipt of Govt. orders, the placement of upgraded A.E.Es. are not disturbed in the seniority list of AEEs. of Zone-I.

As he acquired the ME (Constn.Tech. & Proj. Management) from Andhra University during the year 2012 while in service that too in the year 2012 in the cadre of Dy.E.E., the same will be examined and considered from the year 2012 in the integrated seniority of Dy.E.Es.

Sri S.Ranadev (Sl.No.115 in the revised provisional seniority list of A.E.Es. Zone-I) whose commencement of probation was revised as 2.8.1992 due to application of rule 16(h) of A.P. State and Subordinate Service Rules 1996, does not find place in the seniority list of A.E.Es. of Zone-I now confirmed and his placement will be shown in the next seniority list of A.E.Es. of Zone-I w.r.t. to his revised date of commencement of probation.

Therefore, the Revised Provisional Seniority list of Assistant Executive Engineers of Zone-I communicated vide reference 10th cited, is hereby confirmed duly after taking into consideration of above objections.

The confirmed seniority of A.E.Es. of Zone-I now communicated is subject to outcome of O.As./W.Ps./S.L.Ps., if any, pending before the Hon'ble A.P. Administrative Tribunal / High Court of Andhra Pradesh / Supreme Court of India.
