In the reference 1st cited, the Confirmed Seniority List of Assistant Executive Engineers of Zone-III, was communicated.

Through the reference 2nd cited, Sri Shaik Mardan Ali, Assistant Executive Engineer, RWS&S of Zone-III (presently working as DEE) has raised objection stating that the name of Sri M. Bhaskar Rao, who was repatriated from Zone-V to Zone-III the date of commencement of probation has been shown as 16.04.1986 and he has placed well ahead of his place, even though his date of commencement of probation is 01.01.1989 and requested to rectify the same.

Sri M. Bhaskar Rao, Asst. Executive Engineer, PR belongs to PSC-86 batch in Zone V and was repatriated under G.O.610 to Zone-III. At the time of communication of revised provisional seniority list of AEEs of Zone-III, the commencement of probation has been taken as 16.04.1986 as was in the confirmed seniority list of AEEs.of Zone-V communicated during the year 2007, and kept at Sl.No. 54 and the same was confirmed duly examining the objections received.

But on verification of the records Sri M.Bhaskar Rao, AEE, has passed the account test for PWD officers & Subordinate belatedly and the Government have issued orders revising the date of commencement of probation of the individual w.e.f.01.01.1989, duly applying Rule 16 (h) of APSSS Rules, 1996. As such, his placement in the confirmed seniority list is to be changed with reference to the revised date of commencement of probation.

Hence, the following "ERRATUM" is issued to the above effect.

The Name of Sri M. Bhaskar Rao, stands in the confirmed seniority list, dated. 11.07.2013 at Sl.No. 54 and the date of commencement of probation as 16.04.1986, shall be read as Sl.No. 71 and the revised date of commencement of probation as 01.01.1989
