In the said letter a sum of Rs. 1.5 lakhs was also offered for setting up an investigation unit in the headquarters office of the Chief Engineer, C.R./Hyderabad.

2. The C.I.E.R., with his letter 3rd read above submitted proposals for sanction of additional staff for investigation and execution of P.W.S. schemes under different programmes. The C.I.E.R. has also proposed to set up the Investigation Division two sub divisions, for designs and two sub divisions for designs and two sub divisions, for quality control in his office.

3. Govt. after careful consideration of the proposals of the C.I.E.R., sanctioned the creation of three divisions and three sub divisions with the posts mentioned in the Annexure. I and II to this order for a period of one year for investigation and execution of P.W.S. Schemes.

4. Govt. also sanctioned creation of two sub divisions and 4 posts of Jr. Engineers in the office of the C.I.E.R., for designs and quality control work with the supporting staff as sanctioned in Annexure. III.

5. Execution is also accorded for the purchase of six diesel generators at the rate of one for each division and sub division mentioned in para 3 above.

6. The staff mentioned in para 3 and 4 above will be paid and allowances admissible under the rules.
