The provisional seniority list of Assistant Engineers, PR of Zone.IV covering PSC.LR.82, GO.413 & DMP,83 was communicated and invited objections from them.

The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/2008 & Batch for implementation of Rule 16 (h) of A.P State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA No.10934/08 & Batch.

The Government have issued instructions to implement Rule 16 (h) of A.P. State and Subordinate Service Rules 1996 and requested to identify the individuals who passed Account test belatedly and submit proposals to the Govt. for determining their revised date of commencement of probation, and also to revise the seniority with reference to the dates so revised.

In order to comply with the orders of Hon'ble Courts and orders / instructions of the Government, necessary proposals were submitted to the Govt. to revise the date of commencement and declaration of probation in respect of Asst. Engineers who have not passed Account Test for PWD Officers and Subordinates within their probation period.

The Government have issued orders revising the dates of commencement and declaration of probation vide reference 4th cited, being competent authority.

In pursuance to the Government orders, the date of commencement of probation and declaration of probation are revised in supersession of the earlier orders in regard to the commencement of probation and declaration of probation in respect of the Asst. Engineers who passed account test belatedly vide reference 5th cited.

Further, the Govt. in Memo No.10097/Estt.III/A2/2012-3, dt.06.05.2013 of PR & RD Dept. have instructed to comply with the orders of Hon'ble Tribunal in C.A.No.1911/2012 in O.A.No.8080/97 and C.A.No.1577/2012 in O.A.No. 3239/2009 and to prepare the seniority list by implementing the rule 16(h) of A.P. State and Subordinate Service Rules 1996 within the stipulated time ignoring other aspects.

The Hon'ble High Court of A.P. in its orders dated 21.11.2012 in W.P.No.13273 of 2012 & batch has dismissed the Writ petitions filed by the P.R. Engineering personnel against the orders issued by the Government repatriating them to their respective local cadre in terms of Presidential Order.

Therefore, the Government, have issued instructions to move all the repatriated persons to their respective local zones immediately and revise the seniority list of all the Zones as per rules in force accordingly.

In view of the above it is inevitable to modify the earlier provisional seniority list of Asst. Engineers, PR of Zone.IV and to communicate the revised provisional seniority.

Therefore, in compliance to the orders of Hon'ble Courts and orders / instructions of the Government, duly deleting the name of the Asst. Engineer, PR of Zone.IV (Belated) who was repatriated to Zone.VI and duly incorporating the name of Asst. Engineer, PR who was repatriated to Zone.IV from Zone.III and deleting the names of following Asst. Engineers whose names are not found in this seniority list due to implementation of Rule 16 (h) of A.P. State and Subordinate Service Rules 1996 and their names will be placed at appropriate places in next batches.
