In the reference 5th cited, the Government have permitted the Engineer-in-Chief (PR) Hyderabad, to implement the final orders of the Hon'ble APAT dt.16.07.2014 in O.A.No.2173/2013 subject to outcome of the WP No.22926/2015 pending in the Hon'ble High Court of Andhra Pradesh, if any, on the subject matter and by following due procedure, in the context of C.A. and directed to take further necessary action.

In the reference 6th cited, a revised provisional seniority list of Assistant Executive Engineers of Zone-II, duly deleting the names of the upgraded Asst. Executive Engineers has been communicated duly inviting the objections therein.

In response to the above, the following individuals have filed their objections which are discussed or disposed as follows duly keeping in view the latest orders and instructions.

1.Sri B. Raja Rao, DEE, PIU Sub Division, Vijayawada (Sl.No. 94)

He has raised the following objections:

Gist of the objections:

- a) He passed M.Tech.(GTE) in the year 2001 and the same was recorded in the service register. The same may be corrected as M.Tech. in the revised seniority list. As per the M.Tech. higher Qualification, seniority (i.e. 1:9) may be corrected and his name be placed at appropriate place in the seniority list.

Reply:

As per the records he has passed M.Tech.(GTE) during the year 2001 and the same was recorded in the Service Register. Hence, his objection is considered rectifying the qualification in the confirmed seniority list, as M.Tech. (GTE).

Further, the promotion from the cadre of AEEs to DEEs under PG Slot (i.e., 1:9) has been wind-up from the year 1997-98 onwards. Hence, his objection is over ruled.

- b) He represented that in the communicated seniority list Mr. A.B.Vara Prasad (Sl.No. 100) and Sri G.Mutyam Babu (Sl.No. 160) are already promoted as EE and requested to revert them and to promote him as Executive Engineer under S.C.Category.

Reply:

Sri A.B. Vara Prasad and Sri S.Muthyam Babu, who belongs to LR-85 batch, were repatriated from Zone-V to Zone-II under G.O. 610 and they were placed as per the date of regularization in the allotted zone. Hence, his objection is over ruled.

- c) He represented that the date of commencement of probation was started on 27.04.1985, but in the communicated list, it was noted as 02.05.1985.

Reply:

He was recruited through APPSC -1985 under Limited Recruitment and his services were regularized w.e.f. 27.04.1985. During the years 1997 & 2007, in the confirmed seniority list in respect of AEEs of Zone-II, Sri B. Raja Rao, AEE was placed below Sri M.Ramadas, whose date of regularization is 02.05.1985. Hence, the date of regularization in respect of Sri B.Raja Rao was also restricted to the date of his senior i.e., Sri M. Ramdas. Now Sri M. Ram Das, is attracted rule 16 (h) of APSSS Rules, 1996, as he passed the Account Test for PWD Officers & Subordinates, belatedly and his name was pushed down to Sl.No. 131. Hence, the request of the individual for regularization w.e.f.27.04.1985, i.e., his original date of regularization, is considered.

- d) He was selected in the year 1984 through APPSC against the roaster point 30 of the AP Gazette, dt. 23.08.1984 but his name was not shown against the roaster point and that placement was not given to him, which was against the Rule of Reservation and violating the Rule 22 (e) of APSSS Rule, which deprives the Rule 16 of Indian Constitution.

Reply:

The individual was recruited through APPSC-1985 under Limited Recruitment. Hence, as per his date of regularization, his name was shown at appropriate place along with other LR candidates in Zone-II. His objection to place his name in the carry forward point cannot be considered, as per the prevailing rules. Hence, his objection is over ruled.

2.Smt. T.Satya Kumari, DEE, Sri N.V.R.K.Prasad Babu, DEE & Sri B.Ramanjaneya Prasad,DEE raised one and the same the following objections (upgraded AEEs)

Gist of the Objections:

They represented that they were appointed w.e.f. 24.04.1979/24.04.1979/24.02.1979 respectively as Supervisor. After acquiring B.Tech. Qualification, they were promoted as AEEs, as per G.O.Ms.No. 552, dated. 16.05.1978. Later the Government while issuing amendments for certain provisions in the Service Rules, have issued amendment to the cadre of AEE appointed by transfer vide G.O.Ms.No. 662, dt. 24.11.1987, since the earlier orders issued in G.O.Ms.No. 552, dt. 16.5.78 are only executive orders. They further represented that the awarding of notional dates to such AEEs appointed by transfer has taken different turns due to court directions and Government instructions from time to time. They further represented that the Service Rules issued by Government vide G.O.Ms.No. 15, dated 15.01.199, the provision of appointment as AEE by transfer has been removed.

They represented that they have appointed as DEEs during the years 1997 & 1998 and completed (18) years of service in the same cadre and surprised to see that their names are removed from the seniority lists communicated on 08.03.2016.

They finally represented that it is not justice to remove their names from the seniority list of AEEs after rendering service (19) years as AEE and (18) years as DEE and requested to examine their appeal sympathetically and to include their names in the seniority list of AEEs at appropriate place.

Reply:

As per the available records and orders of the Government and directions of the Hon'ble APAT as discussed above, all the Upgraded AEEs including the above said (3) individuals have been removed from the seniority list of AEEs and their names already shown in the seniority list in the cadre of Asst. Engineers, as per their date of regularization, as per the rules prevailed.

Hence, their objection is over ruled.

The following individuals whose names are covered in the confirmed seniority lists communicated earlier and who were repatriated to their local zones under SPF rules, are hereby deleted in the list now confirmed.

1. Sri P.Y.Ramachandran, AEE PSC-86 Repatriated to Zone-VI (Telangana)
2. Sri N. Arun Kumar, AEE PSC-89 Repatriated to Zone-IV

The following individuals who are working in PR/RWS&S as the case may be, were deleted from the list since they have passed Account Test belatedly and attracting Rule 16(h) and they have not found place in the list now communicated and their names will be shown at the appropriate places in the further seniority lists.
