In compliance to the orders of Hon'ble courts and orders/Instructions of Government, Confirmed seniority list of Assistant Executive Engineers of Zone-III issued vide reference 1st cited was revised and communicated vide this office reference 5th cited, duly inviting objections if any on the ranks assigned to them in the revised provisional seniority list of Assistant Executive Engineers of Zone-III within (15) days from the date of placement of revised provisional seniority list in the Website.

In compliance to the above, certain officers have filed their objections which are discussed and disposed off as follows duly keeping in view of the latest court orders/ directions the reference 2nd cited,

Gist of objection:

They have raised objection that by restricting all upgraded AEEs (who are working from 1984 and most of them are retired long back) to the panel year 24.11.1987, these posts are replaced by juniors in other zones, which effected the seniority of 1986 APPSC batch of Zone-III in the overall integrated seniority list. Again deleting all upgraded AEEs, the promotion of 1986 APPSC batch of Zone-III will be effected adversely and there is no chance of getting promotion from DEEs to EEs even after 30 years of service, as all the deleted upgraded AEEs posts are replaced by 1989 and 1992 batch AEEs of other zones in the integrated seniority list. It is extremely objectionable to delete posts which are already filled by upgraded AEEs long back and now the same posts will be occupied by the juniors in other zones leading to double occupation of one post and also benefiting the zones where more number of upgraded AEEs are available. They have requested to consider for revising the above seniority list without deleting upgraded A.E.Es. as juniors i.e. 1989 and 1992 batch A.E.Es. of other zones will get promotion to E.Es. over the seniors of 1986 batch of this Zone which is very objectionable and unjustified.

Remarks

The Hon'ble APAT has passed orders on 16.07.2014 in OA No.2173/2014 and directed to comply with its order in CA No.332/2015 filed by Sri K.Chandrasekhar Reddy, Dy.E.E.(PR) of Zone.IV. Further, the Government have directed to implement the final orders of the Hon'ble APAT dt.16.07.2014 in O.A.No.2173/2014, subject to outcome of the W.P.No.22926/2015 pending in the Hon'ble High court of Andhra Pradesh, if any, on the subject matter and by following the procedure. Accordingly the upgraded A.E.Es. were deleted from the revised provisional seniority list of A.E.Es. of Zone-III. Hence, their objection is rejected.

Gist of objection:

They have raised objection that the seniority list is against the Hon'ble Supreme Court judgment in G.S.Venkareddy case and it affects their promotions in future in the integrated seniority list, hence they are not accepting the seniority list and confirm the previous seniority list dated 15.10.2013.

Remarks

The Hon'ble APAT has passed orders on 16.07.2014 in O.A.No.2173/2014 and directed to comply with its order in CA No.332/2015 filed by Sri K.Chandrasekhar Reddy, DEE (PR) of Zone.IV. Further, the Government have directed to implement the final orders of the Hon'ble APAT dt.16.07.2014 in O.A.No.2173/2014, subject to outcome of the W.P.No.22926/2015 pending in the Hon'ble High court of Andhra Pradesh, if any, on the subject matter and by following the procedure. Accordingly the upgraded A.E.Es. were deleted from the revised provisional seniority list of A.E.Es. Hence, their objection is rejected.

Further, Sri D.Sudheer Babu, is shown above Sri A.Gurunatham at SL.No.115 in the confirmed seniority list of A.E.Es. of Zone-III since his commencement of probation was revised by the Govt. as 22.6.1986 vide Memo No.27234/E.III/A2/2012-12, dt.20.2.2014.

Therefore, the revised provisional seniority list of Assistant Executive Engineers of Zone-III communicated vide reference 5th cited is hereby confirmed duly taking into consideration of the above objections.

The confirmed seniority list of Assistant Executive Engineers of Zone-III now communicated is subject to outcome of OAs/WPs/SLPs if any pending before the Hon'ble APAT/ High Court of Andhra Pradesh/ Supreme Court of India.

In compliance to the orders of Hon'ble courts and orders/Instructions of Government, Confirmed seniority list of Assistant Executive Engineers of Zone-III issued vide reference 1st cited was revised and communicated vide this office reference 5th cited, duly inviting objections if any on the ranks assigned to them in the revised provisional seniority list of Assistant Executive Engineers of Zone-III within (15) days from the date of placement of revised provisional seniority list in the Website.

In compliance to the above, certain officers have filed their objections which are discussed and disposed off as follows duly keeping in view of the latest court orders/ directions the reference 2nd cited,

I.

1. Sri Ch.Venkata Ramaiah, Dy.E.E., PRI SD, Kondapi
2. Sri S.Venkateswara Raju, Dy.E.E., PIU SD, Venkatagiri
3. Sri P.Ravindra Babu, Dy.E.E., O/o E.in.C(PR)Hyd.

Gist of objection:

They have raised objection that the removal of their names from seniority list is injustice and if any rule is changed it should be applicable from the further onwards and with retrospective effect and it is natural justice to implement any new modifications from the date of issue of the orders not from the previous years and requested to continue their names as A.E.Es. in the seniority list of A.E.Es. of Zone-III. Further, Sri P.Raveendra Babu, Dy.E.E. has requested to grant 15 days time from 29.3.2016 for submitting detailed explanation since he filed WPSR No.55325/2016 challenging the final orders of APAT dt.16.7.2016 in O.A.No.2173/2014 in which he was not impleaded as respondent.

Remarks

The Hon'ble APAT has passed orders on 16.07.2014 in O.A.No.2173/2014 and directed to comply with its order in CA No.332/2015 filed by Sri K.Chandrasekhar Reddy, DEE (PR) of Zone.IV. Further, the Government have directed to implement the final orders of the Hon'ble APAT dt.16.07.2014 in O.A.No.2173/2014, subject to outcome of the W.P.No.22926/2015 pending in the Hon'ble High court of Andhra Pradesh, if any, on the subject matter and by following the procedure. Accordingly the upgraded A.E.Es. were deleted from the revised provisional seniority list of A.E.Es. Hence, their objection is rejected. Grant of time also rejected as Hon'ble APAT directed to implement and report before 12.4.2016.

II.

Gist of the objection of Sri K.Sangeetha Rao, AEE (PR) of Zone-III:

He has raised objection that applying 16(h) in his case is gross violation and injustice as it came into force in 1996 and shall be applied prospectively. The Govt.in Cir.Memo No.57759/Ser.A/2004-1, dt.20.5.2003 and Cir.Memo No.57759/ Ser.A/2004-2, dt.20.5.2004 of GA(Ser.A)Dept. the Govt. has instructed not to consider request for revision of seniority for a period which is more than (3) years old and directed not to re-open the settled seniority as per Apex Court Judgment and requested to include his name in the seniority list without applying penal clause 24(c) / 16(h).

Remarks:

The Hon'ble High Court of Andhra Pradesh has passed final Orders on 18.12.2008 in WP No.22978/ 2008 & Batch for implementation of Rule 16 (h) of A.P State and Subordinate Service Rules 1996. Similar orders were also passed by the Hon'ble APAT on 27.02.2009 in OA No.10934/08 & Batch.

The Government have issued instructions to implement Rule 16 (h) of A.P. State and Subordinate Service Rules 1996 and requested revise date of commencement of probation, and also to revise the seniority in respect of A.E.Es. who have not passed Account Test for PWD Officers and Subordinates within their probation period. Accordingly, the Government have revised the dates of commencement and declaration of probation.

Further, the Govt.in Memo No.10097/Estt.III/A2/2012-3, dt.6.5.2013 of PR&RD Dept. have instructed to comply with the orders of Hon'ble Tribunal in C.A.No.1911/2012 in O.A.No.8080/97 and C.A.No.1577/2012 in O.A.No.3239/2009 and to prepare the seniority list by implementing the rule 16(h) of A.P. State and Subordinate Service Rules 1996 within the stipulated time ignoring other aspects.

The names of the individuals who passed Account Test for PWD Officers and Subordinates belatedly and their revised date of commencement of probation fallen beyond 31.10.1994 (date of joining of Temporary A.E.E. of 1994 batch whose regularization is pending before the Hon'ble High Court) are not shown in the provisional seniority list communicated vide references 1st cited and their names will be shown at appropriate places in the further seniority list of A.E.Es. of Zone-III. Further, as per Hon'ble APAT directions the upgraded A.E.Es. were deleted and revised provisional seniority list of A.E.Es. of Zone-III was communicated vide reference and 5th cited calling for objections in the matter.

Hence, the objection of Sri K.Sangeetha Rao, AEE is rejected since it is not relevant to the present issue. However, as per the earlier decision, his request was rejected and his name will be shown at appropriate place in further seniority list of A.E.Es. of Zone-III.

Therefore, the revised provisional seniority list of Assistant Executive Engineers of Zone-III communicated vide reference 5th cited is hereby confirmed duly taking into consideration of the above objections.

The confirmed seniority list of Assistant Executive Engineers of Zone-III now communicated is subject to outcome of OAs/WPs/SLPs if any pending before the Hon'ble APAT/ High Court of Andhra Pradesh/ Supreme Court of India.
