Chandrasekhar Reddy, Deputy Executive Engineer(PR) of Zone-IV who belongs to Andhra Pradesh State as follows:

"It is represented by the learned counsel for the applicants that the subject matter of these O.As, it squarely covered by subject matter in OA.Nos.1079/2008 and 1082/2008 which were allowed by this Tribunal on 29.06.2012. Therefore, similar relief may be granted to the applicants in the present OA also.

Heard the learned Government Pleader

On verification, we are satisfied that the subject matter of these O.As., is squarely covered by subject matter in O.A.Nos.1079/2008 and 1082/2008, dt.29.06.2012. These OAs are also allowed on the same identical lines as was granted in the said O.A.Nos.1079/2008 and 1082/2008."

The Hon'ble APAT in its orders dated 29.6.2011 in O.A.No.1079/2008 filed by Sri Y.Bhagya Raju, Dy.E.E. of Zone-IV has directed the respondents to delete the names of the unofficial respondents and other Assistant Executive Engineers (upgraded A.E.Es.) from the seniority list and to prepare the seniority list afresh.

Sri K. Chandrasekhar Reddy, Deputy Executive Engineer(PR) of Zone IV has filed C.A.No.332/2015 in O.A.No.2173/2014 and the said C.A. admitted and the Hon'ble APAT has directed to comply with the orders dated 16.7.2014.

In the reference 3rd cited, the Government have permitted the Engineer-in-Chief (PR) Hyderabad, to implement the final orders of the Hon'ble APAT dt.16.07.2014 in O.A.No.2173/2013 subject to outcome of the WP No.22926/2015 pending in the Hon'ble High Court of Andhra Pradesh, if any, on the subject matter and by following due procedure, in the context of C.A. and directed to take further necessary action.

Accordingly in the reference 4th cited, a revised provisional seniority list of Assistant Executive Engineers was communicated duly deleting the names of (9) upgraded Assistant Executive Engineers in the enclosed Annexures.

Under the circumstances explained above, the confirmed seniority list of Assistant Engineers of Zone-III issued vide reference 1st cited is hereby revised duly incorporating the names of (4) Assistant Engineers at appropriate places and a revised provisional seniority list of Assistant Engineers is hereby communicated in the Annexure from Sl.No.(01) to (157) enclosed.

Their objections, if any, along with supported documents as proof in support of their claim should reach in this office within (15) days from the date of placement of this revised provisional seniority list in the website, failing which it will be construed that they have no objection and further action will be taken to confirm the said revised provisional seniority list of Zone-III. Any objections filed after the stipulated time will not be entertained under any circumstances. - 2) Hon'ble APAT orders dated 16.7.2014 in O.A.No.2173/2014 filed by Sri K.Chandrasekhar Reddy, Dy.E.E. of Chittoor District
- 3) Govt. Memo No.14060/Estt.II/2014, dt.8.3.2016 of PR&RD Dept.
- 4) Memo No.Ser-III(2)/43675/2005-1&2, Dated: 08.03.2016.

In the reference 2nd cited, the Hon'ble APAT has passed common orders dated 16.07.2014 in O.A.No.9359/2013 filed by Sri G.Ramulu and (13) other Deputy Executive Engineers of Zone-VI who belong to Telangana State and in O.A.No.2173/14 filed by Sri K. Chandrasekhar Reddy, Deputy Executive Engineer(PR) of Zone-IV who belongs to Andhra Pradesh State as follows:

"It is represented by the learned counsel for the applicants that the subject matter of these O.As, it squarely covered by subject matter in OA.Nos.1079/2008 and 1082/2008 which were allowed by this Tribunal on 29.06.2012. Therefore, similar relief may be granted to the applicants in the present OA also.

Heard the learned Government Pleader

On verification, we are satisfied that the subject matter of these O.As., is squarely covered by subject matter in O.A.Nos.1079/2008 and 1082/2008, dt.29.06.2012. These OAs are also allowed on the same identical lines as was granted in the said O.A.Nos.1079/2008 and 1082/2008."

The Hon'ble APAT in its orders dated 29.6.2011 in O.A.No.1079/2008 filed by Sri Y.Bhagya Raju, Dy.E.E. of Zone-IV has directed the respondents to delete the names of the unofficial respondents and other Assistant Executive Engineers (upgraded A.E.Es.) from the seniority list and to prepare the seniority list afresh.

Sri K. Chandrasekhar Reddy, Deputy Executive Engineer(PR) of Zone IV has filed C.A.No.332/2015 in O.A.No.2173/2014 and the said C.A. admitted and the Hon'ble APAT has directed to comply with the orders dated 16.7.2014.

In the reference 3rd cited, the Government have permitted the Engineer-in-Chief (PR) Hyderabad, to implement the final orders of the Hon'ble APAT dt.16.07.2014 in O.A.No.2173/2013 subject to outcome of the WP No.22926/2015 pending in the Hon'ble High Court of Andhra Pradesh, if any, on the subject matter and by following due procedure, in the context of C.A. and directed to take further necessary action.

Accordingly in the reference 4th cited, a revised provisional seniority list of Assistant Executive Engineers was communicated duly deleting the names of (9) upgraded Assistant Executive Engineers in the enclosed Annexures.

Under the circumstances explained above, the confirmed seniority list of Assistant Engineers of Zone-III issued vide reference 1st cited is hereby revised duly incorporating the name of Sri Ch. Venkata Ramaiah at appropriate place and a revised provisional seniority list of Assistant Engineers is hereby communicated in the enclosed Annexure from Sl.No.(01) to (55).

This memo along with its Annexure is available in the website of the PRED at www.pred.gov.in. No separate seniority list will be communicated to each officer. Therefore, they are requested to download the same and go through and treat it as a notice and file their objections, if any, on the ranks assigned to them in the revised provisional seniority list of Assistant Engineers of Zone-III.

Their objections, if any, along with supported documents as proof in support of their claim should reach in this office within (15) days from the date of placement of this revised provisional seniority list in the website, failing which it will be construed that they have no objection and further action will be taken to confirm the said revised provisional seniority list of Zone-III. Any objections filed after the stipulated time will not be entertained under any circumstances. The revised provisional seniority list now communicated is subject to final outcome of the W.P.No.22926/2015 filed against the Hon'ble APAT orders dated 16.07.2014 in O.A.No.9359/2013 filed by Sri K. Chandrasekhar Reddy, Dy.E.E.(PR) of Zone IV, which is pending in the Hon'ble High Court of Andhra Pradesh and also O.As./W.Ps./SLPs., if any, pending in the Courts/Tribunal.
