

## **NOTES ON PENSIONS**

1. Old Pension Rules. Who retired prior to 01-04-1961.
2. A.P Liberalised Pension Rules 1961 W.E.F 01-04-1961
3. A.P govt servants family pension Rules 1964

G.O M.S.No 56 Finance (Pen-1) dept. 24-2-1964 All Government servants appointed regularly to pensionable posts on or after 01-01-1964

All government servants who held pensionable posts on 01-01-1964 in regular capacity and all governed wholly by the old pension rules by exercising option on or before 31-07-1974.

4. A.P revised pension Rules 1980 in two parts {Part-1 and Part II}

G.O.M.S. No. 88 Fin & Plng. (FW-PSC-IV), dept dt.26-03-1980

Part I ----- with effect from 29-10-1979

Part II ----- applicable to all Government servants holding pensionable posts on 31-03-1978 and Who retired between 01-04-1978 and 28-10-1979

Option A) within six months before attaining the age of superannuation and

B) in the case of invalidation from service or voluntary retirement or compulsory retirement within 15 days of the occurrence of the said event.

C) in the case of those who ;have already retired or died subsequent to 28-10-1979, within 3 months from the date of issue of these rules failing which they shall be deemed to have elected to continue to remain in the pension rules by which they are governed on 28-10-1979. The option once exercised shall be final.

Note: In case of failure to exercise option, the retired employee is deemed to have opted to the pension rules which are more beneficial to him/her. This applies to family pension case also .

## **The Government of Andhra Pradesh Revised Pension Rules 1980**

G.O.M.S. No.88 F&P (FW PSC IV) dept. dt. 26<sup>th</sup> March 1980

(Part –I Rules ) with effect from 29<sup>th</sup> October 1979

Part –II of these rules which shall be deemed to have come into effect from 1<sup>st</sup> April 1978.

### **1. Commencement of qualifying service:**

Subject to the provisions of these rules, qualifying service of a government servant shall commence from the date he takes charge of the post to which he is first appointed either substantively or in an officiating or temporary capacity Rule 13

In Registration and stamps department service as T.S.W qualifies for pension with effect from 26-05-1979 .

G.O.M.S.No 721 Revenue (V) dept dt. 26-05-1979

G.O.M.S..No. 1194 revenue(Regn – 1) dept. dt 02-12-1994

Minimum qualifying service to get service pension is 10 years

Maximum qualifying service is 33 years to get full pension

Service below 10 years is eligible service gratuity

( vide table under rule 45(1) A)

Calculation for service pension 33/66th of 10 months average emoluments.

### **2. “Death cum Retirement gratuity”**

Renamed as

“Retirement gratuity”

G.O.M.S No. 353 Finance dt. 10-10-1977

R.G = 1/3rd of the last drawn pay for every 6 monthly period of qualifying service, subject to a maximum of 20 months pay and further not exceeding Rs.30000/-  
(Period from 29-10-1979 to 30-01-1982)

R.G: enhanced to Rs. 36,000/- with effect from 31-01-1982

(G.O.M.S.No. 208 Finance and planning dt.31-07-1982)

3. Calculation of 10 months of average has been dispensed with w.e.f 25-05-1998.

(G.O.M.S.No.87 F&P (F.W.Pen 1) dept. dt. 25-05-1998)

As per the orders of the Hon'ble APAT Hyderabad dt.03-01-2002 and as per Supreme Court Judgment dated 30-04-2014, orders issued in G.O.M.S.No 87 Fin &Plg.( FW Pen1) dept. dt.25-05-1998 for calculation of pension based on the pay last drawn is extended to all employees retired prior to 25-05-1998 and surviving on that date.

G.O.M.S.No. 223 Finance (HRM VI) department dated 15-12-2014

Note: Arrears from 25-05-1998 to 31-03-2015 or death of the service pensioner whichever is earlier to be paid in 3 installments (1<sup>st</sup> installment 01-04-2015, 2<sup>nd</sup> installment 01-11-2015 and 3<sup>rd</sup> installment Oct 2016.)

“ The last pay drawn shall be treated as emoluments for fixation of pension under rule 45(2) (B) of A.P. Revised pension rules 1980, instead of average of last 10 months emoluments as per rule 32 of revised pension rules 1980, provided officiating in a promoted post during the last two months preceding the retirement is in a regular vacancy”.

G.O.MS.NO. 87 F&P (Fin Pen 1) dept. Dt. 25-05-1998

Clarification letter no. 108/A2/pension 1/99 F&P (FW pension ) department.

The orders issued in para 3 of G.O.M.S.No. 87 F&P dt.25-05-1998, are clear and they are applicable to the persons who are promoted during the period of last 2 months in a regular vacancy. As such the persons promoted in a regular vacancy is eligible for the benefit irrespective of number of days they acted in promoted post.

As per G.O.M.S.NO. 235 Finance dept. dt.27-10-1998, if the date of increment of a government servant falls due on the day following his retirement, such increment will be sanctioned notionally for the purpose of calculation of pension and gratuity. These orders will be effective with effect from 27-10-1998. The notional pay shall not be taken for the calculation of encashment of earned leave, at the time of retirement.
